This is to inform you that Corporate Governance Report under Regulation 27(2) of SEBI(Listing Obligations and Disclosure Requirements), 2015 is not applicable to our company.

Further, we would like to clarify that our company is claiming exemption under Regulation 15 (2) of SEBI (LODR) Regulations, 2015 the Compliance with the Corporate Governance Provisions as specified in regulation 17 to 27 and clauses (b) to (i) and (t) of sub-regulation (2) of 46 and paras C, D and E of Schedule V of SEBI (LODR) 2015 shall not apply in respect of:

1. A listed entity which has listed its specified securities on the SME Exchange. or
2. The listed entity being a SME having paid up equity share capital not exceeding rupees ten crore and net worth not exceeding rupees twenty-five crore, as on the last day of previous financial year.
