

- The Consolidated results include results of its subsidiaries Star Cement Meghalaya Limited (SCML), Star Century Global Cement Private Limited (SCGCL), Star Cement (B) Limited (SCL) and Star Cement North East Limited (SCNEL).
- During the quarter, Star Cement Limited has commissioned its interlinker plant with installed capacity of 3.3 MTPA at Lumshong on 21st April 2024.
- SCNEL had commenced its cement production at its grinding unit located at Suwahati on 12th March 2024. The subsidiary has opted to pay lower income tax under section 115BBA of the Income Tax Act, 1961.
