This is with reference to our earlier communication from time to time vide which we had informed that the Hon'ble High Court at Calcutta has restrained the Company by an Order dated 5th September, 2023 of temporary injunction passed in GA/1/2023 in CS/186/2023 from publishing the voting result or acting in terms of the voting result pertaining to Resolution no. 8 of the Addendum dated 14th August, 2023 to the Notice of 103rd Annual General Meeting (AGM) of the Company relating to the appointment of Mr. Sudeep Roy, for the office of Director proposed by a Member viz. The Punjab Produce & Trading Co. Pvt. Ltd. under Section 160 of the Companies Act, 2013.

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that the Hon'ble High Court at Calcutta vide its Order dated 17th December, 2025 has disposed of GA/1/2023 in CS/186/2023 without passing any further Order. It has inter alia been observed by the Hon'ble Court that the Interim order passed on 5th September, 2023 had expired and as such, there is no embargo on the Company or the defendants to give effect or further effect to the decision taken at the Annual General Meeting held on 5th September, 2023.

The said Order was received by the Company on 18th December, 2025 at around 5.56 p.m. (IST).
