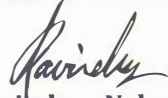
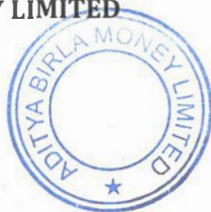
The effective date of his appointment as Senior Management Personnel of the Company shall be **September 24, 2026.**

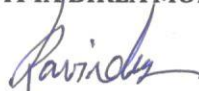
