Pursuant to Regulation 30 read with Para A of Part A of Schedule III of Listing Regulations, we hereby inform you that the two vehicles carrying raw materials of the Company were detained by the Officer of State Tax, Uttarakhand under Central Goods and Service Tax Act/ Uttarakhand Goods and Service Tax Act, for wrong entry of the Principal Business Place in the E-Invoices.

The Orders both dated January 1, 2025, levying penalty in this regard were received by the undersigned on January 6, 2025 at 06.10 pm. As per the said Orders, the penalty of Rs 17,94,816 for each vehicle, in all aggregating to Rs 35,89,632 was levied.

The Company has paid the prescribed penalty amount and both the vehicles have now been released. The Company is in the process of filing an appeal for the refund of the said penalty amount.

The said Orders have no material impact on the financials, operations or other activities of the Company.
