Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI LODR Regulations”), read with Part A of Schedule III thereto and other applicable provisions, we hereby inform you that the company had made acquisition of 18,800 shares representing 47% of the paid-up capital/voting rights of Blue Water Logistics Company Limited, Thailand (“Target Company”), subject to the terms and conditions as may be mutually agreed and applicable statutory/regulatory approvals, if any.

The Target Company had become an **Associate Company** of the Company in accordance with the applicable provisions of the Companies Act, 2013 and applicable accounting standards.

Details with respect to acquisition as required under provisions of Regulation 30 read with Schedule III of The SEBI (LODR) Regulations, 2015 and in terms of SEBI Master Circular bearing Ref. No. HO/49/14/14(7)2025-CFD-POD2/1/3762/2026 issued on July 11, 2023 and updated on January 30, 2026, is enclosed as an Annexure – A. Kindly take the aforesaid information on record.

With reference to the Letter No. BWL/037/2026-27 dated August 04, 2026, wherein the Company had inadvertently mentioned the establishment/opening of a Branch Office in Thailand, we hereby clarify that the said disclosure was made due to an inadvertent oversight and typographical error.

We wish to clarify that the entity referred to in the aforesaid letter is, in fact, an Associate Company of Blue Water Logistics Limited and not a Branch Office of the Company.

Accordingly, the reference to “Branch Office” in the said letter may kindly be read and construed as “Associate Company”. The Company regrets the inadvertent error and requests the Stock Exchange to kindly take the above clarification on record and consider the aforesaid letter accordingly.

The Company assures that due care shall be exercised in making future disclosures to ensure accuracy and compliance with the applicable provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.
