This summer, U'khand forest fires killed 2, gutted 258 ha

Dehradun: Two people, including a forest fire watcher, have died in recent forest fire-related incidents in Uttarakhand. With rising temperatures, the state has been witnessing a surge in forest fire cases — at least 309 of them since the summer forest fire season began — which have gutted almost 258 hectares of jungles, reports Shivani Azad.

Rajinder Singh Negi, 42, a forest fire watcher, died after falling into a deep gorge while extinguishing a blaze in Chamoli forests on Wednesday evening. In a separate incident, Anju Devi, 50, died while trying to douse a fire that was raging in her farm in Tehri. Her charred remains were found by her son late Wednesday.

Divisional forest officer (DFO) of Chamoli, Sarvesh Dubey said, "A forest fire extinguishing team of 16 workers had gone to douse the fires in Dasoli area that had flared up around 3pm. About four hours later, I was told that one of the fire watchers was missing after which an overnight search operation took place. His body was subsequently found. He had slipped into a deep gorge." Incensed at the death, villagers gheraoed the DFO, demanding a relief package for the family.

4th India-Africa meet postponed amid Ebola scare

Delayed Second Time Due To Virus Outbreak

New Delhi: The much-delayed 4th India-Africa summit that India was to host from May 28 to 31 was postponed on Thursday on account of the deadly Ebola virus outbreak in Democratic Republic of Congo. Though not yet a global pandemic, the risk posed by virus made WHO declare a health emergency of international concern earlier this week.

This is the second time that an Ebola outbreak has led to postponement of India-Africa summit.

The last summit that India hosted was originally scheduled for Dec 2014 but could take place only 10 months later for the same reason.

India also reaffirmed its solidarity with Africa in a press release, expressing its readiness to contribute to the Africa CDC (Centres for

Govt steps up Ebola screening at airports

India has stepped up Ebola surveillance and screening measures at airports after WHO declared Ebola outbreak in parts of Africa a "public health emergency of international concern", with health authorities issuing a fresh advisory for passengers arriving from or transiting through affected countries, reports Anuja Jaiswal.

The health ministry has maintained that no Ebola case has been reported in India so far, but surveillance is being strengthened as a precautionary step.

Travellers coming from the Democratic Republic of Congo, Uganda and South Sudan are to immediately report health officers if they experience relevant symptoms.

Disease Control and Prevention-led efforts to address the evolving health situation, in line with the country's shared commitment to an Africa-led response.

Pocso convict 'electrocuted' in HP, kin cry foul

Kullu: A Pocso convict died under mysterious circumstances inside Dharamsala district jail in Himachal Pradesh, triggering allegations of foul play and a demand for an independent investigation.

Vivek of Khaniara was serving a seven-year sentence. "My son was rightly punished. He was serving his sentence but it was not a death sentence. All I want is justice for him," said his father, Jagdish Chand.

Jail superintendent Vikas Bhatnagar said Vivek was electrocuted inside his cell around 5.34pm Wednesday. "It seems he touched the bars of the cell. Jail staff heard a scream and rushed to his cell to find him lying unconscious," said Bhatnagar, adding the inmate was taken to Govt Medical College where he was declared dead.

100 tigers under surveillance in Kanha as viral infection kills 6

Bhopal: Madhya Pradesh wildlife HQ has placed more than 100 tigers in Kanha National Park under close surveillance, following six Canine Distemper Virus (CDV)-linked tiger deaths, even as an expert team from National Tiger Conservation Authority, Bengaluru, has called for a scientific sero-prevalence study of stray dogs and cats around Kanha to map viral circulation and shape long-term disease prevention strategies.

The alert follows the recent deaths of tigress T-141 and her four cubs in Kanha's Sarhi range, and a male tiger, aged around 5-6 years, in Mukhri range Tuesday.

Testing conducted by School of Wildlife Forensic and Health, Jabalpur, confirmed the presence of CDV through RT-PCR analysis, leading authorities to conclude that all fatalities were linked to the viral infection.

The NTCA team has recommended closer monitoring of stray dog movement

near tiger habitats, continued testing of water sources and carnivore samples, stricter regulation of food waste around tourism facilities, and priority vaccination of dogs in villages surrounding the reserve, with concerns that infected canines may be the most likely pathway for the virus to enter Kanha's tiger landscape.

Chief wildlife warden Samita Rajora has constituted a special monitoring team with instructions to maintain an "over-cautious" watch on tiger behaviour.

45 warships to be delivered in 3-4 years: Vice Admiral

New Delhi: Around 45 ships are under construction within the country and will be delivered in the next 3 to 4 years, Navy vice chief Vice Admiral Sanjay Vatsyan has said in Kolkata during the launch of 'Sanghamitra', the first of four next-generation offshore patrol vessels (GOPVs) built by defence PSU Garden Reach Shipbuilders and Engineers (GRSE) Ltd for the Navy, reports Surendra Singh.

Vice Admiral Vatsyan also revealed Wednesday that Navy has received in-principle approval for 195 naval vessels as part of future vessel programmes. "We have got Acceptance of Necessity (nod) for another 69 ships, six submarines and another 120 fast in-tensorcrafts. There is a big opportunity for the defence building ecosystem to deliver quality products in time with the required capabilities," he said.

68 weapons, huge cache of ammo seized in Manipur; 4 held

Guwahati: Security forces and various law enforcement agencies, in a joint operation over the past 24 hours, seized 68 sophisticated weapons and large quantities of ammunition stashed inside a rebel camp in Manipur's Imphal West district, reports Prabin Kalita.

Authorities also arrested four cadres of United National Liberation Front (Pambl), a faction of UNLF that signed a ceasefire agreement with Centre and state in Nov 2023.

Officials said UNLF (P) was intending to sell the weapons in an illegal arms market. Many of the weapons were suspected to have been looted from state armouries during the peak of the ethnic conflict that began May 2023. Police were verifying the source of the suspected loot, Imphal East SP Shivnand Surve said.
