In terms of Regulation 30 of SEBI (Listing Obligations and Disclosures Requirements) Regulations, 2015 (“SEBI LODR Regulations”), we hereby wish to inform you that a First Information Report bearing No. 172/25 dated December 12, 2025 at Police Station - Economic Offence Wing, Delhi lodged by PG Paper Company Limited, an entity based in United Kingdom (“Complainant”) against total Nine (9) parties including our Company and our Promoter, Skyways Air Services Limited under Section 406, 409, 420, 467, 468, 471 and 120B of the Indian Penal Code, 1860 and Section 316(2), 316(5), 318(4), 338, 336(3), 340(2), 61(2) of Bharatiya Nyaya Sanhita 2023 (“BNS”) alleging criminal breach of trust, cheating, creation and use of fake documents and causing wrongful loss to the Complainant.

The Company became aware of the existence/registration of the aforesaid FIR upon receipt of a notice dated February 03, 2026 from Police Station - Economic Offence Wing, Delhi seeking production of documents. However, our Company has got the copy of the aforementioned FIR much later.

The Company categorically denies all the allegations made by the Complainant and is in the process of seeking appropriate legal remedies against such allegations. Further disclosures will be made as and when there are material developments, as required under SEBI LODR Regulations.
