Pursuant to Regulation 30 read with Schedule III to the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“**SEBI Listing Regulations**”) and Regulation 10(c) of Securities and Exchange Board of India (Share Based Employee Benefits and Sweat Equity) Regulations, 2021, (“**SEBI SBEB Regulations**”), we hereby inform that the Nomination and Remuneration Committee of Brainbees Solutions Limited (“**Company**”) on Thursday, March 6, 2025 approved the allotment of total of 9,84,699 (Nine Lakhs Eighty Four Thousand Six Hundred Ninety Nine Only) Equity Shares and transfer of total of 5,37,359 (Five Lakhs Thirty Seven Thousand Three Hundred Fifty Nine Only) Equity Shares of face value of Rs. 2/- each fully paid up against the exercise of vested Options as detailed below:
