महिला एवं बाल विकास विभाग के शासन सचिव डॉ. मोहन लाल यादव ने प्रदेश के सभी जिला कलक्टर को जीएन-श्रीषण एवं मरम्मत नहीं कराने योग्य आंगनवाड़ी भवनों को सर्वजनिक निर्माण विभाग के सहयोग से नियमानुसार नकारा घोषित कराने के निर्देश दिए हैं। ताकि केन्द्र एवं राज्य सरकार से नवीन भवन का निर्माण कराया जा सके। शासन सचिव यादव के अनुसार जिला कलक्टर अपने-अपने जिलों में समेकित बाल विकास सेवाओं की ओर से संचालित आंगनवाड़ी केन्द्रों, जिनका निर्माण जिला परिषद या अन्य संस्थाओं की ओर

सरकार ने डिस्ट्रिक्ट कार्यावाही कराने के लिए निर्देश

से 15 से 30 वर्ष पूर्व हुआ है। उनमें कुछ भवन बहुत अधिक जर्जर हो गए हैं। जिन जर्जर भवनों में मरम्मत संभव है। उनकी तो मरम्मत कराएँ और मरम्मत संभव नहीं होने पर सार्वजनिक निर्माण विभाग के सहयोग से नियमानुसार नकारा घोषित कराएँ। ताकि अर्बिलव डिस्ट्रिक्ट की कार्यवाही करते हुए केन्द्र एवं राज्य सरकार से राशि प्राप्त कर पुनः नवीन भवन का निर्माण कराया जा सके। उल्लेखनीय है कि आंगनवाड़ी केन्द्रों के भवन

कई क्षेत्रों में 60 घंटे के बाद भी नहीं आया पानी

कॉर्स/अजमेर। जलदाय विभाग के जिले के मुख्य पॉपिंग स्टेशनों पर सोमवार को दिनभर बिजली की अर्थभिमौली से मांग के अनुरूप पानी नहीं मिलने से शहर की जलापूर्ति व्यवस्था एक बार फिर चरमरा गई। कई क्षेत्रों में 48 से 60 घंटे के बाद भी सप्लाई नहीं होने से लोग परेशान रहे। विभाग के एएसई भुवनेश्वर अग्रिहोत्री ने बताया कि थडोली, केकड़ी, गोयला, नसीराबाद पंप हाउस पर दिन में कई बार बिजली गुल रही। सुबह 7.20 से शुरू हुई बिजली की आर्थभिमौली सायं 3.40 बजे तक चली। जिससे पंप बंद रहने से जल उत्पादन प्रभावित रही। अग्रिहोत्री ने बताया कि शहर को करीब 15 एमएलडी पानी कम मिला। जिससे कई क्षेत्रों में निर्धारित अंतराल में जलापूर्ति नहीं हो सकी। जिन क्षेत्रों में सप्लाई का अंतराल 48 घंटे से अधिक हो गया है, वहां मंगलवार को प्राथमिकता से पानी दिया जाएगा।
