FM urges US companies to make in India for the world

New Delhi, August 29

FINANCE MINISTER NIRMALA Sitharaman on Saturday exhorted US businesses and investors to co-develop, co-produce, and build in India, leveraging its engineering talent, manufacturing scale, and technology ecosystem to create global products, technologies and infrastructure.

During the US leg of her two-nation visit, Sitharaman addressed a high-level roundtable with leading investors and business leaders in Chicago. “The finance minister invited global partners to co-develop, co-produce and build for global markets, and to not merely consider India as a market to serve, but as a platform from which to build for the world — whether as a manufacturing base, technology and innovation centre, consumer market or destination for long-term infrastructure investment, leveraging India’s engineering talent, manufacturing talent, technology ecosystem,” the finance minister said in a post on X.

The roundtable focused on India’s broad-based growth,

reform momentum and expanding opportunities for long-term investment, with “manufacture in India — for India and for the world” emerging as a key theme. Opportunities were highlighted across manufacturing, AI and digital technologies, financial services, infrastructure, food processing, defence and advanced technologies.

In her address, Sitharaman outlined “Why India, Why

Now”, pointing to strong domestic demand, investment-led growth, macroeconomic resilience, a deep talent pool and rapidly expanding digital and physical infrastructure. As global companies reassess supply chains and capital allocation, she said India offers not only scale as a market but also increasing depth as a long-term investment and operating platform.

On digital and AI, Sitharaman highlighted India’s digital public infrastructure, including Aadhaar, UPI, Digital Locker, ONDC and India Stack, which has created platforms at population scale. The next opportunity, she said, lies in higher-value businesses spanning AI, engineering, analytics, product development, semiconductors and electronics, with global capability centres increasingly evolving into global innovation hubs.

India, Argentina in talks for expansion of lithium mining

INDIA’S FIRST MINING initiative in Argentina, Khanij Bidesh India (KABIL), has progressed significantly with the completion of its Phase II of drilling. The mine is located in Catamarca province of Argentina. Both countries are now engaged in expanding operations to other prospective mines.

Opportunities are now being explored for further engagement in the provinces of Salta and Jujuy to deepen the strategic partnership between the two countries, a Commerce Ministry statement on the fourth meeting of the India-Argentina Joint Trade Committee (JTC) said.

The talks on expansion of critical minerals partnership were figured at the JTC meeting held on August 24 in Buenos Aires. The Indian delegation was led by Commerce Secretary Rajesh Agrawal, while the Argentine delegation was led by Secretary for International Economic Relations Fernando Brun.

KABIL is a public sector joint venture of Nalco, Hindustan Copper and Mineral Exploration Consultancy under India’s Ministry of Mines. It has signed an exploration and development contract with the state-owned company of Argentina and has obtained exclusivity rights for exploration and development of lithium blocks in the Catamarca province of Argentina.

In April, the Argentine government granted a formal environmental clearances to KABIL, enabling deep exploration, borehole drilling, and brine sampling. Argentina is part of the South America Lithium Triangle, which also includes Chile and Bolivia. This region holds 50-60% of the world’s identified lithium resources. India’s proposed trade agreement with Chile also has provisions of critical mineral trade.

CNG prices up ₹3.89/kg in Delhi amid West Asia crisis

CNG PRICES IN Delhi-NCR rose by ₹3.89 per kg on Saturday, the fifth increase this year, as the renewed West Asia crisis disrupts LNG cargo movements through the Strait of Hormuz and forces city gas distributors to absorb sharply higher imported gas costs.

Indraprastha Gas (IGL) said the revised price will take effect from 6 am on August 29, raising cost of CNG in Delhi to ₹86.98 per kg. Prices will increase to ₹95.59 per kg in Noida and Ghaziabad, ₹95.47 per kg in Meerut and ₹92.01 per kg in Gurugram, respectively.

The latest revision is the first since May, when IGL raised CNG prices by a cumulative ₹6 per kg in four phases over ten days as global energy prices surged following the West Asia conflict.

“With international LNG prices remaining elevated and the cost impact becoming increasingly significant, a call-

brated revision of ₹3.89 per kg has now become necessary to partially offset the increase in input gas cost,” IGL said.

The price increase comes as IGL relies on imported spot LNG for a significant portion of

gas required to meet rising CNG demand. Since July, re-escalation of the West Asia crisis has affected LNG cargo movements through Hormuz, while European demand has strengthened as countries increase gas storage ahead of winter.

The impact is visible in global benchmarks. The Asian JKM LNG benchmark jumped around 113%, from about \$10.99 per MMBtu in late February to \$23.41 by August 27. Europe’s TTF gas benchmark surged roughly 105%, from \$11.36 per MMBtu to \$23.35 during the same period.

In comparison, Delhi’s CNG retail price had risen only around 7.8% to ₹83.09 per kg from ₹77.09 per kg between late February and August 27, before the latest revision, according to IGL.

The company said consumers, including private-car owners, auto and taxi operators and public transport users, had largely been insulated from the full impact of volatile imported LNG prices.

Ather aims for 2K stores; Konarc set to drive sales

ATHER ENERGY IS preparing for an aggressive expansion of its retail footprint and manufacturing capacity as it looks to scale up volumes with its newly launched mass-market electric scooter, Konarc. Priced at ₹99,999 ex-showroom, the scooter is expected to become Ather’s largest-volume model as early as next year, even as the company plans to more than double its manufacturing capacity.

With Konarc broadening



Ather’s product portfolio, the company now has enough products to support a much larger retail network, co-

founder and chief executive Tarun Mehta said. It is targeting 1,500-2,000 retail stores across the country over the next few years.

“With a product like Konark, our portfolio is now wide enough to afford somewhere in the vicinity of 1,500-2,000 retail stores across the country. This is a target that we will take over the next few years,” Mehta said. The company has made its largest investment yet in a new product, with the EL1 platform and Konarc development expected to require ₹400-500

crore or more. The investment excludes go-to-market and marketing expenses and covers product development, including research and development and testing.

“Platform investments precede product investments, which remain substantial. Ather began work on the platform in 2019, but paused before picking it up again around 2024, making it roughly a two-year effort. The platform and product together will involve an investment of ₹400-500 crore or likely more,” Mehta said.

We support Singapore Airlines' Air India investment, says Temasek

SINGAPORE’S SOVEREIGN WEALTH fund Temasek on Saturday said it supports Singapore Airlines’ investments in Air India and highlighted that the Indian carrier’s large-scale transformation involves complex, multi-year operational and integration challenges.

A statement from Temasek, which is a stakeholder in Singapore Airlines (SIA), comes against the backdrop of concerns raised in certain quarters about the carrier’s investment in the loss-making Air India.

Singapore Airlines owns a 25.1% stake in Air India, and the remaining shareholding is with Tata Sons, which acquired the Indian airline from the government in January 2022.

Temasek on Saturday said SIA has articulated its objective to invest in a second hub to secure long-term growth beyond Singapore. —PTI

FSSAI bans hing sale by Everest, Laljee Godhoo

THE FOOD SAFETY and Standards Authority of India (FSSAI) on Saturday prohibited the sale of compounded asafoetida (hing) manufactured by Everest Food Products and Laljee Godhoo and Company, after laboratory tests found samples to be sub-standard and non-compliant of the prescribed quality standards. For Everest, samples were found to have alcohol soluble extract at 0%, against the prescribed minimum limit of 5%. Its yellow and black hing samples recorded 3.29% and 4.4%, respectively. FSSAI said similar non-compliance was found in surveillance samples collected from various sources.

The regulator said the non-compliances were considered pervasive across batches. The sale of compounded hing by both companies has been prohibited with immediate effect until further orders.
