**DUE DILIGENCE REPORT AS REFERRED IN SEBI MASTER CIRCULAR –FOR
DEBENTURE TRUSTEES DATED MAY 16, 2024(AS AND WHEN UPDATED)**

We B. K. Kothari & Associates LLP, Chartered Accountants (Firm Registration Number W100372) have reviewed the unaudited books of accounts, the registers, records, and papers of **L&T FINANCE LIMITED (FORMERLY KNOWN AS L&T FINANCE HOLDINGS LIMITED)** Mumbai (“The Company”) having its registered office at **Brindavan, Plot No. 177, C.S.T Road Kalina, Santacruz (East) Mumbai 400098, Maharashtra, India**, as required to be maintained under The Company’s Act, 2013 (“The Act”) and the rules made thereunder, the provisions of various statutes, wherever applicable, the provisions contained in the Memorandum and Articles of Association of the Company, wherever applicable as well as the provisions contained in the Listing Agreement if any, entered into by the company with recognized stock exchanges’.

Management’s Responsibility

The preparation of the accompanying Statement from the unaudited books of account, financial results of the Company for the period under review and other relevant records and documents is the responsibility of the Management of the Company, including the preparation and maintenance of all accounting and other relevant supporting records and documents. This responsibility includes designing, implementing and maintaining internal control relevant to the preparation and presentation of the Statement, and applying an appropriate basis of preparation; and making estimates that are reasonable in the circumstances. The Management is also responsible for compliance with the covenants of the Offer Document/Information Memorandum in the manner as may be specified by SEBI and adherence with all other applicable conditions mentioned in the Regulations in connection with the Statement.

Our Responsibility

Pursuant to the requirements of the Regulations, our responsibility is to provide a due diligence report as referred in SEBI circular “*SEBI Master Circular*” *Master Circular for Debenture Trustees dated May 16, 2024 (As and when Updated)*. This does not include the evaluation of adherence by the Company with all the applicable guidelines of the Regulations.

The financial results for the quarter ended June 30th, 2025 have been reviewed by us, on which we issued an unmodified conclusion vide our due diligence report dated August 18th, 2025.

A review is substantially less in scope than an audit conducted in accordance with Standards on Auditing specified under section 143(10) of the Companies Act, 2013 and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an audit. Accordingly, we did not express an audit opinion. We have no responsibility to update our reports for events and circumstances occurring after the date of the report.

We conducted our review of the Statement in accordance with the Guidance Note on Reports or Certificates for Special Purposes issued by the ICAI. The Guidance Note requires that we comply with the ethical requirements of the Code of Ethics issued by the ICAI. We have complied with the relevant applicable requirements of the Standard on Quality Control (“SQC”) 1, Quality Control for Firms that perform Audits and Reviews of Historical Financial Information, and Other Assurance and Related Services Engagements.

In our opinion and to the best of our information and according to the examination carried out by us on the documents of the Company and explanations furnished to us by the Company and its officers in this regard, we report for the aforesaid period as under:

1. The Company has created, modified or satisfied charges of the assets of the company given as security against listed debt securities shown in detail in **Annexure A** attached with this report as we have taken search report as on 18/08/2025.
2. The Company:
 - (a) Has issued and allotted non-convertible debentures in compliance with the specified procedures and within the stipulated time during the period under review.
 - (b) Has redeemed its debentures in compliance with the specified procedures and within the stipulated time.
3. The Company has policy to insure all its secured assets which are given as security against issue of listed Debt securities.
4. The name of the company and or any of its directors does not appear in the defaulters list of Reserve bank of India.
5. The Company had used the funds borrowed out of Issue of Listed Debt securities for the purpose for which it was borrowed.
6. According to the information and explanation given to us and to the best of our knowledge there is no prosecution initiated against or show cause notices received by the Company for alleged defaults/offences under various statutory provisions and there were no fines and penalties imposed on the Company and any other action initiated against the Company and / or its directors for period under review.

7. The company has complied with the provisions of SEBI (Listing Obligations and Disclosures Requirement) Regulations, 2015.
8. The company has obtained balance confirmation certificates/statements of loan account at cut-off date from all lenders who are entitled to the charge on Pari passu basis. The company has also obtained reconciliation statement for the accounts in case there is difference (if any) in the amount of loans as per lenders & as per books of the Company.
9. The Company has on records the title deeds of all the assets proposed to be charged to Debenture Holders (if any) which includes title reports issued by a legal counsel/ advocates, copies of the relevant agreements/ Memorandum of Understanding, copy of evidence of registration with Sub-registrar, Registrar of Companies, Central Registry of Securitization Asset Reconstruction and Security Interest (CERSAI) etc.
10. The Company has provided a management representation for unencumbered assets, that the assets on which charge is proposed to be created are free from any encumbrances
11. As per the information and explanation furnished to us by the Company, the company does not create any charge on already encumbered assets. The charges for secured lenders are either Pari Passu or exclusive. There are no multiple charges on any assets/ receivables of the company.
12. Pursuant to the requirements of the Regulations, as referred in SEBI circular, "*SEBI Master Circular*" *Master Circular for Debenture Trustees dated May 16, 2024 (As and when Updated)* relevant annexure namely **Annexure A** separately attached with this report below which forms an integral part of the Due Diligence report.
- 13(a). The Board of directors of the company had approved scheme of amalgamation by way of merger by absorption (Scheme) on March 20, 2020. Pursuant to receipt of necessary orders from National Company Law Tribunal (NCLT), Mumbai and Kolkata, sanctioning the scheme of amalgamation by way of merger by absorption of L&T Housing Finance Limited and L&T Infrastructure Finance Company limited with the company, under section 230 to 232 of the companies act 2013, the scheme become effective on April 12, 2021. On and from the appointment date i.e., April 01, 2020, the company has accounted for amalgamation as a common control business combination in accordance with Appendix C of the Indian Accounting Standards (Ind AS) 103- "Business Combinations". According to the information reported below figures represent the aggregate balance of the amalgamated company from appointment date April 01, 2020.
- 13(b). The Board of directors of the company had approved scheme of amalgamation by way of merger by absorption (Scheme) on October 17, 2023. Pursuant to receipt of necessary orders from National Company Law Tribunal (NCLT), Mumbai and Kolkata, sanctioning the scheme of amalgamation by way of merger by absorption of L&T Finance Limited, L&T Infra Credit Limited and L&T Mutual Fund Trustee Limited with the company, under section 230 to 232 of the companies act 2013, the scheme become effective on November 08 2023. On and from

the appointment date i.e., April 01,2023, the company has accounted for amalgamation as a common control business combination in accordance with Appendix C of the Indian Accounting Standards (Ind AS) 103- “Business Combinations”. According the information reported below figures represent the aggregate balance of the amalgamated company from appointment date April 01, 2023.

14. We have examined the compliances made by the listed entity in respect of the covenants/terms of the issue of the listed debt securities (NCD's) and certify that the company has maintained 100% security cover as per terms of offer documents or debenture trust deed at all the time on total amount outstanding for the NCD's as at 30th June 2025 and such covenants/terms of the issue as prescribed have been complied by the listed entity.
