I, Shehul Sandip Parikh S/o Sandip P Parikh, 5/38 Sagarmahal chs, 65 Walkeshwar Rd , Mumbai 400006, was a member of Promoter Group in the Company who is presently not holding any shares of the Company. I was classified as a member of Promoter Group in the Company at the time of Preferential issue about 15 years back. Since from last FY 2020-2021. I am in no way associated to the business of management of the Company.

Further I am not engaged in the management of the Company and also do not have any right either to appoint any Director of the Company or an ability to control the management or policy decisions of the Company in any manner whatsoever including by virtue of my shareholding and that none of my acts would influence the decision making in the Company Accordingly I request you to reclassify myself from "Promoter Group" category to "Public category shareholder.

I Shehul Sandip Parikh sold my entire holding of 25,000 equity shares of Burnpur Cement Limited in two tranches during August 2020 in open market:

- First Tranche: 16,996 shares sold on 4th August 2020 through Sharekhan Limited in Open Market (Contract Note No. 7062782, Trade Date: 04/08/2020, Settlement Date: 06/08/2020) at a price of Rs. 1.30 per share.
- Second Tranche: The remaining 8,004 shares were sold on 12th August 2020 through Sharekhan Limited in Open Market (Contract Note No. 7581951, Trade Date: 12/08/2020, Settlement Date: 14/08/2020) at a price of Rs. 1.35 per share.

The transaction amount of Rs. 30766/- (Rupees Thirty Thousand Seven Hundred Sixty Six Only) was received from Sharekhan Limited after deduction of Taxes And Charges in Shehul Parikh HDFC BANK Saving Bank Account No 00141000102071 of Huges Road Branch on 21 August 2020.

My name also has been removed by the Company in list of promoters since FY 2022-23, 2023-24, 2024-25 till date from Annual reports of the company.

In connection with application for reclassification, I hereby confirm and certi\$r that:

- I. I along with persons related to me together:
 - a. do not hold more than ten percent of the total voting rights in the company. b. do not exercise control over the affairs of the company, directly or indirectly.
 - C. do not have any special rights with respect to the company through formal or informal arrangements including through any shareholder agreements.
 - d. are not being represented on the board of directors (including not having a nominee director) of the Company
 - e. do not act as a key managerial person of the Company.
 - f. are not 'wilful defaulter(s)' as per the Reserve Bank of India Guidelines
 - g. are not fugitive economic offender.
- 2. There is no pending regulatory action against me.
- 3. I shall continue to comply with the conditions mentioned at sub-clauses (1), (ii) and (ii) of clause (b) of Regulation 3 IA(3) of SEBI (Listing Obligation and Disclosure

Requirements) Regulations, 2015 at all times from the date of reclassification, failing which, I shall be reclassified as promoter/ person belonging to the promoter group of the company.




