Sub: Newspaper publication regarding special window for re-lodgement of transfer requests of physical shares

Tamil Nadu building 28,551 housing units at Rs. 3,766 cr

Chennai, June 12: Housing and Urban Development Minister P. Rajkumar on Thursday said that 28,551 multi-storey housing units are currently under construction across 60 project locations in Tamil Nadu at a total cost of Rs.3,766.24 crore under the Tamil Nadu Urban Habitat Development Board (TNUHDB). The Minister disclosed the details while chairing a review meeting on the Board's headquarters in Chennai. His meeting was held under the guidance of Chief Minister C. Joseph Vijay and in the presence of TNUHDB Chairman K.P. Krishnan. Rajkumar said that in Chennai, 7,179 housing units are being built in 21 project areas at a cost of Rs.1,230.42 crore. In other districts, 21,372 housing units are under construction in 39 project areas at an investment of Rs.2,535.82 crore. He further stated that under the Asian Development Bank-assisted programme, 5,457 housing units are being constructed in six project locations at a cost of Rs.1,030 crore. In



addition, renovation and rehabilitation works are underway in 215 project areas at an estimated cost of Rs.210 crore. The Minister instructed officials to ensure that the housing units being developed for economically weaker sections are completed on schedule and delivered with high standards of quality and structural safety. The review meeting was attended by Housing and Urban Development Department Principal Secretary R. Kirlosh Kumar, TNUHDB Managing Director Shreya P. Singh, Joint Managing Director Anamika Ramesh, Secretary C. Venkatesh, Financial Adviser S. Shanmuganathan, and senior engineering and administrative officials.

Door-to-door drive to complete ration card eKYC

Chennai, June 12: Additional Registrar of Cooperative Societies (Consumer Affairs) K. Tharppagaraj has directed fair price shop staff to undertake door-to-door visits to complete pending eKYC registrations linked to family ration cards and ensure that all beneficiaries are brought under the system without delay. During an inspection of fair price shops and cooperative pharmacies operated by the Chennai Park Town and Vannarapettai Cooperative Wholesale Stores on Thursday, Tharppagaraj reviewed the functioning of public distribution outlets and essential service facilities. He visited the Kumaran Nagar Fair Price Shop

under the Park Town Cooperative Store and the Periyar Nagar Fair Price Shop under the Vannarapettai Cooperative Store, where he examined the quality of essential commodities being distributed and reviewed the overall functioning of the outlets. The Additional Registrar instructed staff to expedite the completion of pending eKYC registrations and advised them to visit beneficiaries' residences to ensure full coverage within the stipulated time. He also directed officials to undertake renovation and maintenance works at the Vannarapettai Cooperative Wholesale Store building to improve infrastructure and enhance service delivery. Interacting with



members of the public, Tharppagaraj enquired whether essential commodities were being supplied in the prescribed quantities without interruption and sought feedback on any grievances or difficulties faced by consumers. Later, he inspected cooperative pharmacies functioning in both localities and instructed staff to ensure uninterrupted procurement and availability of commonly used medicines. He also reviewed the home delivery system for medicines and issued directions to ensure prompt and efficient supply to beneficiaries. Senior officials and employees of the Cooperative Department accompanied the Additional Registrar during the inspection.

Nutrition & weight management training for SC/ST youth

Tiruvannamali, June 12: The Tamil Nadu Adi Dravidar Housing and Development Corporation (TAHDCO) has invited applications from Scheduled Caste and Scheduled Tribe youth for specialised training courses in Nutrition & Dietetics

and Slimming & Weight Loss, aimed at enhancing employability and livelihood opportunities. Announcing the programme, Tiruvannamali Collector Vandana Garg said the initiative is part of TAHDCO's ongoing efforts to improve the socio-economic status of Adi Dravidar and Tribal communities through skill-based training. Applicants must belong to the Scheduled Caste or Scheduled Tribe

communities, have passed Class XII, be aged between 18 and 35 years, and have an annual family income of less than Rs.3 lakh. The 50-day training programme will be conducted in Ranipet and Tiruvallur districts. TAHDCO will bear hostel and accommodation expenses for eligible candidates who stay in the training districts during the course period. Candidates who successfully complete the training will receive placement support through the training institution, with expected starting salaries ranging from Rs15,000 to Rs.20,000 per month. Eligible candidates from Tiruvannamalai district can register online through TAHDCO Official Website to avail themselves of the opportunity, the Collector said.
