With reference to the captioned subject and pursuant to Regulation 30 read with Para of Part A of Schedule III of the SEBI Listing Regulations and in continuation to our earlier intimation as referred above, regarding the receipt of demand under section 73 of the GST Act 2017 raising demand pursuant to the assessment order passed by the Office of Assistant Commissioners of Commercial Taxes LGSTO-090, Bangalore -DGSTO-3 (Karnataka) vide order reference No: ZD291223100779A dated December 30, 2023 for the financial year 2017-18, against which we had filed an appeal before the Commissioner (Appeals).

We have now received the order from the Joint Commissioner (Appeal) LGSTO 090 – Bengaluru, DGSTO-3, Bengaluru, Karnataka (Karnataka State GST).

We would like to emphasize that, based on the merits of the case, prevailing legal provisions, and expert advice, the Company intends to appeal this order before the GST Appellate Tribunal and reasonably anticipates a favourable outcome.
