With reference to the captioned subject, we would like to inform you that the Company has received an order from the office of the Deputy Commissioner, Vijayawada, Andhra Pradesh, for the period April 2021 to March 2022 imposing demand of INR 9,20,854 /- (Tax INR 5,21,508 /-, Interest – INR 3,47,195/- and penalty of INR 52,151/-)

Based on the merits of the matter, prevailing law and advice of the consultant, the Company is planning to appeal against this order before the Commissioner (Appeals) and reasonably expects favourable orders from the appellant authorities.
