Pursuant to Regulation 31 of the Securities and Exchange Board of India (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 ("SEBI SAST Regulations"), we hereby notify the Exchange that Mr. Murtaza Ali Soomar, a Promoter of the Company, has acquired 5,400 (Five Thousand Four Hundred) equity shares of the Company at a price of ₹358.10 (Rupees Three Hundred Fifty-Eight and Ten Paise Only) per equity share on March 3, 2025, and an additional 5,400 (Five Thousand Four Hundred) equity shares at a price of ₹340.20 (Rupees Three Hundred Forty and Twenty Paise Only) per equity share on March 4, 2025, through open market transactions.
