Dear Sir / Madam,

This is with reference to the email received from the Exchange on 24.06.2026 regarding non-submission of the Statement on Impact of Audit Qualifications in respect of the modified opinion contained in the Audited Financial Results of the Company for the half year and financial year ended 31 March 2026.

At the outset, we sincerely regret the inadvertent omission and the consequent delay in submission of the said Statement. We wish to submit that the omission was purely unintentional and occurred due to an oversight while compiling and uploading the final PDF/XBRL submission package on the Exchange portal.

We would like to inform you that the Independent Auditor's Report on the Audit of Half Yearly and Annual Consolidated Financial Results of the Company contains a Qualified Opinion. The said qualification, as appearing in the Audit Report, is reproduced below for your ready reference:

*"The Group had consolidated APEX ADVANCED TECHNOLOGY, LLC as a subsidiary up to 07 November 2025, being the date up to which the Holding Company had control over the said entity. Consequent to conversion of debt into equity by another shareholder, the Holding Company's shareholding/control was reduced and the said entity ceased to be a subsidiary and became an associate with effect from 08 November 2025.*

*As per the AS-23, investment in an associate is required to be accounted for in the consolidated financial statements using the equity method. However, the management has not made available to us the audited financial statements/management accounts and other relevant financial information of the said associate for the period from 08 November 2025 to 31 March 2026, including information relating to post-acquisition profits/losses, changes in net assets, significant transactions/events, accounting policy adjustments and disclosures required for application of the equity method.*

*Consequently, we were unable to obtain sufficient appropriate audit evidence regarding the carrying value of investment in the associate, the Group's share of profit/loss of the associate, the consequential impact on consolidated profit/loss, reserves and surplus, net worth, earnings per share, total assets and related disclosures. In the absence of such information, the impact of the above matter on the consolidated financial results is presently not ascertainable. "*

Pursuant to the change in ownership and control of APEX ADVANCED TECHNOLOGY, LLC, the Company presently holds only a minority interest and does not exercise control over the said entity. Accordingly, the financial statements / relevant financial information of APEX ADVANCED TECHNOLOGY, LLC for the period from 08 November 2025 to 31 March 2026 were subject to availability from the controlling management of the said entity. Since such information was not available to the Company within the reporting timelines, the same could not be incorporated in the present submission. Accordingly, the financial impact of the said audit qualification could not be quantified by the Company and its Auditors, and the same has been reported by the Auditors.

We are pleased to inform you that we have now successfully submitted the Statement on Impact of Audit Qualifications in the prescribed format through the NSE Electronic Application Processing System (NEAPS) portal. A copy of the same, duly signed by the Managing Director, Chief Financial Officer, Audit Committee Chairman, and Statutory Auditor, is attached herewith for your records.

Further, we also enclosed you with the Machine-readable Form / Legible Copy of Financial statements which could not submitted earlier.

# The audit qualification relates to the non-availability of audited financial statements/management certified accounts and other relevant financial information of M/S APEX ADVANCED TECHNOLOGY, LLC for the period from 08 November 2025 to 31 March 2026, which was required for consolidation of the investment in the associate under the equity method in accordance with AS 23.

In the absence of such information, the auditors were unable to determine the Group's share of profit/loss, changes in net assets and the consequential impact, if any, on the carrying value of investment in the associate, consolidated profit/loss, reserves and surplus, net worth, earnings per share, total assets and related disclosures.

Accordingly, the impact of the audit qualification is presently not ascertainable and, therefore, no adjustments have been made to the audited figures reported in the consolidated financial statements. Consequently, the figures reported under the column "Adjusted Figures (audited figures after adjusting for qualifications)" are the same as the figures reported under the column "Audited Figures (as reported before adjusting for qualifications)".

**II. Audit Qualification (each audit qualification separately):**

**a. Details of Audit Qualification:**

The Group had consolidated APEX ADVANCED TECHNOLOGY, LLC as a subsidiary up to 07 November 2025, being the date up to which the Holding Company had control over the said entity. Consequent to conversion of debt into equity by another shareholder, the Holding Company's shareholding/control was reduced and the said entity ceased to be a subsidiary and became an associate with effect from 08 November 2025.

As per Accounting Standard (AS) 23, "Accounting for Investments in Associates in Consolidated Financial Statements", investment in an associate is required to be accounted for using the equity method in the consolidated financial statements. However, the management has not made available the audited financial statements/management accounts and other relevant financial information of the associate for the period from 08 November 2025 to 31 March 2026.

The information not made available includes details relating to post-acquisition profits/losses, changes in net assets, significant transactions/events, accounting policy adjustments and disclosures required for application of the equity method.

Consequently, the auditors were unable to obtain sufficient appropriate audit evidence regarding:

- Carrying value of investment in the associate;
- The Group's share of profit/loss of the associate for the period;
- Consequential impact on consolidated profit/loss;
- Reserves and surplus;
- Net worth;
- Earnings per share;
- Total assets; and
- Related disclosures in the consolidated financial statements.

In the absence of such information, the impact of the above matter on the consolidated financial statements for the year ended 31 March 2026 is not ascertainable.

**d. For Audit Qualification(s) where the impact is quantified by the auditor, Management's Views:**

Not Applicable, since the impact of the qualification could not be quantified

**e. For Audit Qualification(s) where the impact is not quantified by the auditor:**

**(i) Management's estimation on the impact of audit qualification: -**

The impact of the qualification is presently **Not Ascertainable**, as the financial statements and other relevant financial information of APEX ADVANCED TECHNOLOGY, LLC for the period from 08 November 2025 to 31 March 2026 have not been received.

**(ii) If management is unable to estimate the impact, reasons for the same:**


The Holding Company having lost Majority control over the Subsidiary, does not presently have access to the financial statements/management accounts and other financial information of APEX ADVANCED TECHNOLOGY, LLC for the period during which it was classified as an associate. Accordingly, the management is unable to determine the Group's share of profit/loss, changes in net assets and other adjustments required under AS 23 and therefore cannot reliably estimate the financial impact on the consolidated financial statements.

**(iii) Auditors' Comments on (i) or (ii) above:**

Based on the information and explanations provided to us, the management has not been able to provide audited or certified Financial Statements of M/S APEX ADVANCED TECHNOLOGY, LLC for the period from 08 November 2025 to 31 March 2026 due to loss of Management Control over the erstwhile subsidiary. Accordingly, we are unable to determine/quantify the effects, if any, on the carrying value of investment in the associate, share of profit/loss, consolidated profit/loss, reserves and surplus, net worth, earnings per share, total assets and related disclosures. Therefore, the impact of the matter remains unascertainable.

Accordingly, in terms of AS 13 – Accounting for Investments, the Company has recognised a provision for diminution in the value of investment amounting to ₹ 1,121.44 lakhs

## Independent Auditor's Report

### Independent Auditor's Report on Audit of Half Yearly and Annual Standalone Financial Results of the Company Pursuant to the Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended)

#### To the Board of Directors of Cadsys (India) Limited,

We have audited the accompanying Statement of standalone financial results of Cadsys (India) Limited ('the Company') for the half year and year ended 31<sup>st</sup> March, 2026 (the Statement) being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("LODR Regulations").

In our opinion and to the best of our information and according to the explanations given to us, the Statement:

- (i) Is presented in accordance with the requirements of Regulation 33 of the Listing Regulations, and
- (ii) gives a true and fair view in conformity with the recognition and measurement principles laid down in the Accounting Standard 25 "Interim Financial Reporting" ("AS 25") prescribed under section 133 of the Companies Act, 2013 (the "Act") read with relevant rules issued thereunder and other accounting principles generally accepted in India of the net loss and other financial information of the Company for the half year and year ended 31<sup>st</sup> March, 2026.

#### Basis for Opinion

We conducted our audit of the standalone financial statements in accordance with the Standards on Auditing ("SAs") specified under section 143 (10) of the Companies Act, 2013. ## Independent Auditor's Report

### Independent Auditor's Report on Audit of Half Yearly and Annual Consolidated Financial Results of the Company.

#### To the Board of Directors of Cadsys (India),

We have audited the accompanying Statement of Consolidated Financial results of Cadsys (India) Limited ('the Company') and its Subsidiaries (the Company and its Subsidiaries together referred to as the "Group"), its associates for the half year and year ended 31 March, 2026 (the Statement) being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as amended ("LODR Regulations").

In our opinion and to the best of our information and according to the explanations given to us, and based on the consideration of the reports of the other auditors on separate financial statements of subsidiaries, associates the Statement:

- (i) Includes the Results of the following entities: Apex Engineers (India) Private Limited, and Cadsys Technologies LLC, USA as subsidiaries and Apex Advanced Technologies LLC as subsidiary only up to 07<sup>th</sup> November 2025,
- (ii) Is Presented in accordance with the requirements of Regulation 33 of the LODR Regulations.

#### Basis for Qualified Opinion

We conducted our audit of the Consolidation financial statements in accordance with the Standards on Auditing ("SA" s) specified under section 143 (10) of the Companies Act, 2013. Our responsibilities under those Standards are further described in the Auditor's Responsibilities for the Audit of the Consolidation Financial results section of our report. We are independent of the Group in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India ("ICAI") together with the ethical requirements that are relevant to our audit of the Consolidation financial results for the half year and year ended march 31,2026 under the provisions of the Act and the Rules made there under, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the ICAI's Code of Ethics.

We believe that the audit evidence obtained by us is sufficient and appropriate to provide a basis for our Qualified audit opinion.

The Group has consolidated **APEX ADVANCED TECHNOLOGY, LLC** as a subsidiary up to 07 November 2025, being the date up to which the Holding Company had control over the said entity. Consequent to conversion of debt into equity by another shareholder, Cadsys India Ltd's shareholding/control was reduced and the said entity ceased to be a subsidiary and became an Associate with effect from **08 November 2025**.

As per the AS-23, investment in an Associate is required to be accounted for in the consolidated financial statements using the equity method. However, the management has not made available to us the audited financial statements/management accounts and other relevant financial information of the said associate for the period from 08 November 2025 to 31 March 2026, including information relating to post-acquisition profits/losses, changes in net assets, significant transactions/events, accounting policy adjustments and disclosures required for application of the equity method.



Consequently, we were unable to obtain sufficient appropriate audit evidence regarding the carrying value of investment in the associate, the Group's share of profit/loss of the associate, the consequential impact on consolidated profit/loss, reserves and surplus, net worth, earnings per share, total assets and related disclosures for the period from 8<sup>th</sup> Nov.2025 to 31<sup>st</sup> March'2026. In the absence of such information, the impact of the above change on the consolidated financial results is presently not ascertainable.

### Qualified Opinion

In our opinion and to the best of our information and according to the explanations given to us, **except for the possible effects of the matter described in the Basis for Qualified Opinion paragraph**, the accompanying consolidated annual financial results give a true and fair view in conformity with the recognition and measurement principles laid down in the applicable Accounting Standards prescribed under Section 133 of the Companies Act, 2013 read with relevant rules issued there under and other accounting principles generally accepted in India, of the consolidated net loss other financial information of the Group for the period ended 31st March 2026.

### Emphasis of Matter

We draw attention to Note No. 07 to the accompanying consolidated financial statements, which describes that Apex Technologies ceased to be a subsidiary of the Parent Company with effect from 08 November 2025 consequent to loss of control/dilution of holding. Accordingly, the financial results of Apex Technologies have been consolidated on a line-by-line basis only up to 07 November 2025, being the date up to which the parent-subsidiary relationship existed. From 08 November 2025, the investment in Apex Technologies has been accounted for as an associate under the equity method.

As stated in the said Note, consequent to the change in status of Apex Technologies from subsidiary to associate during the year, the consolidated financial statements for the year ended 31 March 2026 are not strictly comparable with those of the previous year / earlier periods to the extent that Apex Technologies has been consolidated line by line only up to 07 November 2025 and has been accounted for as an associate thereafter.

Our opinion is not modified in respect of this matter.
