In compliance with Regulations 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with Schedule III (including any statutory modification(s), amendment(s) or reenactment(s) thereof for the time being in force), this is to inform you that the Board of Directors of **CANARYS AUTOMATIONS LIMITED** (formerly known as Canarys Automations Private Limited) ("the **Company**") has approved and passed following resolutions by way of circulation on today i.e. 25th February 2025.

1. Approved the declaration of Interim dividend on Unlisted Cumulative Redeemable Preference Shares.

In accordance with the terms of issue of Unlisted Cumulative Redeemable Preference shares issued on 01st February 2021, the Board has declared Interim dividend on 31,20,000 outstanding unlisted Cumulative Redeemable Preference shares of Rs.10/- each at 10% for the period from 01st April 2024 to 31st January 2025 (i.e., for 10 months) amounting to Rs. 26,00,000/- (Rupees Twenty-Six Lakhs Only) on pro-rata basis, payable to those preference shareholders whose name appear in the register of preference shareholders as on 31st January 2025 (Record Date).

2. Approved the redemption of Unlisted Cumulative Redeemable Preference Shares as per terms of issue.

In accordance with the terms of the issue of 52,00,000 Unlisted Cumulative Redeemable Preference shares of Rs.10/- each issued on 01st February, 2021, the Board of Directors of the Company has approved the redemption of 15,60,000 unlisted Cumulative Redeemable Preference shares (i.e. 30% of 52,00,000 unlisted Cumulative Redeemable Preference Shares of Rs.10/- which were due for redemption on 01st February 2025) at par aggregating to Rs. 1,56,00,000/- (Rupees One Crore Fifty-Six Lakhs only) out of profits of the Company.

Further, pursuant to the SEBI Master Circular No. SEBI/HO/CFD/PoD2/CIR/P/2023/120 dated July 11, 2023 read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 disclosure is hereby made that the Board of Directors has approved the redemption of the aforesaid Unlisted Cumulative Redeemable Preference Shares, out of the available Profits/ Reserves of the Company.

After the above redemption, the Preference Share capital of the Company will be reduced to Rs. 1,56,00,000 divided into 15,60,000 unlisted Cumulative Redeemable Preference Share of Rs.10/- each from Rs. 3,12,00,000 divided into 31,20,000 unlisted Cumulative Redeemable Preference Share of Rs.10/- each.
