Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI LODR"), and in continuation of our earlier disclosure dated February 13, 2025, regarding the petition filed by the Company under Section 7 of the Insolvency and Bankruptcy Code, 2016, before the Hon'ble National Company Law Tribunal, Mumbai Bench ("NCLT"), against Epitome Residency Private Limited for recovery of outstanding dues amounting to ₹18,04,17,518/- (Rupees Eighteen Crore Four Lakh Seventeen Thousand Five Hundred and Eighteen only), we wish to inform you that the Hon'ble NCLT has, vide its final order dated 22.04.2025, admitted the said petition and initiated Corporate Insolvency Resolution Process (CIRP) against Epitome Residency Private Limited.

Further, the NCLT has appointed an Interim Resolution Professional (IRP) in the matter.

The Company shall be filing its financial claim before the IRP in accordance with the provisions of the Insolvency and Bankruptcy Code, 2016.
