Xiaomi's POCO to tap into India's premium smartphone market

New Delhi, August 22

The premium smartphone segment in India as a category is currently dominated by OnePlus, Apple and Samsung. In a recent interview, Xiaomi V-P and India MD Manu Jain said that while the company was focussing on mid and mass categories - which occupy the biggest share of the market - it was also keen on expanding its presence in the above ₹20,000-price category.

"POCO - which launched its maiden smartphone 'F1' priced at ₹20,999 onwards - will use the manufacturing and supply chain as well as the after-sales network of the Chinese parent. "POCO brand is focussed on innovation and has a different positioning. Our first handset - F1 - is for the power users... We don't think POCO will impact Xiaomi sales, POCO will be complementary to Xiaomi," its global head Alvin Teo said.

Over the past few years, a number of handset makers like Huawei (Honor) and Micromax (Yu) have launched sub-brands to cater to the Indian consumers. POCO F1 features Qualcomm Snapdragon 845 platform, Liquid-Cool cooling system technology, up to 6GB RAM and 256 GB storage, along with 4,000 mAh battery. The device - in multiple variants - will hit the shelves in India on August 29 and roll out around the world gradually.

"POCO stands for little" as a small outfit within Xiaomi, POCO has the freedom to start from scratch, zeroing in on the product choices and technologies that matter. The brand focusses on delivering performance and innovation, which we believe will resonate with tech enthusiasts," said J Manu, head of product at POCO Global.

मुंबई, दि. २२ (प्रतिनिधी) : मुंबईत काही महिन्यांपूर्वी तपासलेल्या अग्निशमन यंत्रणेप्रकरणी सुमारे साडेतीन हजार इमारतीमधील अग्निशमन प्रतिबंधक यंत्रणा बसवलीच नसल्याची धक्कादायक माहिती समोर आली आहे. या इमारतींना नियमांचे पालन करण्याच्या सूचना पालिकेने दिल्या आहेत परंतु, बहुतांश इमारतींनी केराची टोपली दाखविल्याने यंत्रणेचे तीनतेरा वाजल्याचे समोर आले आहे.
राज्यभरात अशा ५८८ परवानाधारक एजन्सी आहेत. या एजन्सीपैकी २४० मुंबईभरात आहेत. मुंबईत उभारल्या जाणाऱ्या इमारतींना नियमानुसार अग्निशमन यंत्रणा बसवणे बंधनकारक आहे. या यंत्रणांचे दर सहा महिन्यांनी लेखापरिक्षण करून त्याचा अहवाल संबंधित विभागाकडे जमा करणे आवश्यक आहे. मात्र अनेक सोसायट्या याकडे लक्ष देत नाहीत. ही यंत्रणेची तपासणी केली. यावेळी तब्बल साडेतीन हजार इमारतीतील अग्निशमन यंत्रणा फेल ठरल्याचे समोर आले. अग्निशमन दलाने अशा सोसायट्यांना यंत्रणेत तात्काळ दुरुस्ती करण्याचे आदेश दिले. मात्र अजूनही बहुतांश इमारतींनी त्याकडेही दुर्लक्ष केल्याने सुरक्षिततेचा मुद्दा ऐरणीवर आला आहे.
