The details of any change in the status and / or any development in relation to such proceedings;	The Company vide intimation dated April 30, 2024, had informed about the rejection of the arbitration proceedings invoked by Mr. Nimish Shah and Ors. against the Company vide award dated April 29, 2024.
		Subsequently, on July 31, 2024, the Company had reported that Mr. Nimish Shah and Ors. filed a commercial arbitration petition before Hon'ble Bombay High Court, challenging the rejection of the arbitration claim.
		In furtherance to the above, the commercial arbitration petition filed by Mr. Nimish Shah and Ors. was allowed vide order dated December 23, 2025, and the award dated April 29, 2024, was set aside by the Hon'ble Bombay High Court.
		The disclosure for the above Order dated December 23, 2025, is made in compliance with Regulation 30 of SEBI Listing Regulations read with Industry Standards Forum note as the cumulative amount under matters having similar question of law and factual matrix cross the materiality threshold.
		The Company had already made intimations on abovementioned dates to disclose details of arbitrations arising from alleged misutilization of clients' securities by Anugrah Stock & Broking Private Limited.
