In terms of Regulation 30 read with Schedule III of the SEBI (LODR) Regulations, 2015, we wish to inform you that the Board of Directors of the Company in their meeting held on today i.e. Tuesday, October 29, 2024, at the registered office of the Company, *inter-alia*, considered and approved the following businesses:

ALLOTMENT OF 80,00,000 (EIGHTY LAKHS) EQUITY SHARES TO NON-PROMOTERS, PUBLIC CATEGORY AND 30,00,000 (THIRTY LAKHS) FULLY CONVERTIBLE WARRANTS TO PROMOTER GROUP ON PREFERENTIAL BASIS

Pursuant to the members' approval obtained through postal ballot on October 07, 2024 by means of passing a Special Resolution and 'In-Principle Approval' obtained from the Stock Exchange i.e. National Stock Exchange of India Limited on October 16, 2024;
