Pursuant to Regulation 30 read with Sub-para (20) of Para (A) of Part (A) of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, and in continuation of the Company's earlier intimation dated June 24, 2025 regarding receipt of Demand cum Show Cause Notice from the Directorate General of Goods and Services Tax Intelligence (DGGI), Surat Zonal Unit, we hereby inform that the Company has received an Order-in-Original passed by the Joint Commissioner, Central Goods and Services Tax & Central Excise, Surat Commissionerate.

The Order-in-Original has been passed pursuant to the aforesaid Show Cause Notice alleging misclassification of certain PU (Polyurethane) insulated products supplied by the Company and its subsidiaries under the Goods and Services Tax laws.

The Company is in the process of evaluating the Order-in-Original and will be availing appropriate legal remedies, including filing of an appeal before the appellate authority within the prescribed timelines. The financial impact, if any, will be appropriately considered in accordance with applicable accounting standards.

The relevant details as per the requirement of Regulation 30 of the Listing Regulations, read with SEBI Circular SEBI/HO/CFD/PoD-1/P/CIR/2023/123 dated July 13, 2023 and Master Circular no. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024 are given in the enclosed 'Annexure - A'.
