In continuation to our earlier intimation dated 06.11.2025, we would like to inform that the Competition Commission of India ("CCI") vide its Letter no. C-2026/02/1383/993 dated 03rd March 2026 has approved the proposed combination related to acquisition of 1.09% additional equity in Generali Central Insurance Company Limited (GCICL) and 0.82% additional equity in Generali Central Life Insurance Company Limited (GCLICL) by Central Bank of India. Copy of the said Letter issued by CCI is enclosed herewith.

Upon completion of the proposed acquisition, the Bank's shareholding in Generali Central Insurance Company Limited (GCICL) and Generali Central Life Insurance Company Limited (GCLICL) will increase from the existing level of 24.91% and 25.18% respectively to 26%.
