The Company ("Centum") wishes to inform that it has entered into a Memorandum of Understanding (MoU) with Garden Reach Shipbuilders & Engineers Limited ("GRSE") on 8th October 2025 at GRSE Bhavan, Kolkata. This is a significant step towards advancing indigenous capability in high-technology navigation systems for the Indian Navy.

GRSE is a Defence Public Sector Undertaking under the administrative control of the Ministry of Defence and is classified as a Schedule 'A' Mini Ratna Category I company. It is a leading shipyard in the country engaged primarily in building of ships for the Indian Navy, Indian Coast Guard and other government and non-government customers, and in ship repair and general engineering activities including manufacture of deck machinery and other engineering items.
