**CITY SAW 20 INCHES OF RAIN SINCE MONDAY: MUNICIPAL COMMISSIONER**

## 7,600 shifted to safer places as creek level rises in Surat

THE SURAT Municipal Corporation (SMC), with the help of rescue teams, on Wednesday shifted and evacuated around 7,600 people to safer areas mainly from the low lying areas of Udhna, Limbayat and Varachha, officials said.

Municipal Commissioner M Nagarajan said the city saw 20 inches of rain since Monday even as the water level in the creeks crossed the danger mark. Schools, colleges and anganwadis remained closed for the second consecutive day on Wednesday.

Apart from Surat city, suburbs of Kamrej (16 inches) and Palsana (18 inches) talukas in Surat district also received heavy rainfall, disrupting normal life. Udhna, Varachha, Limbayat, Ved Road, Sagrapura areas also reported power outages on Tuesday night.

Nagarajan said, "A red alert was declared by the Meteorological Department and in the past 48 hours starting Monday, over 20 inches of rainfall was recorded in Surat city. Water



levels in Bhedwad and Mithi Creeks have also risen, exceeding the danger level due to heavy rainfall in the upper catchment areas. Over 4,000 people have been shifted while 3600 people have been rescued and moved to safer places. We have distributed over 20,000 food packets, 9,700 water bottles and 4,000 milk pouches to the affected citizens."

With some respite from the rain on Wednesday, the SMC began a door-to-door health surveillance drive. "We have alerted the citizens still trapped

due to rainwater and are taking care of their medical facilities and foods. In those areas where the water receded, we sent our cleaning teams. We have also started a door-to-door survey to find out whether anyone is ill and medical teams are sent there simultaneously. The situation is presently under control," Nagarajan said.

The State Emergency Operation Centre in Gandhinagar deployed six teams of the National Disaster Response Force (NDRF) in Surat to carry out rescue and shifting operations in those areas where water entered houses, shops, factories, etc. In the early hours on Wednesday, the teams shifted 153 males, 67 females and 35 children from Shiv Shakti society in the Dindoli area. These people were given shelter in the SMC schools and community halls, where they were provided food packets and drinking water bottles. Apart from this, the NDRF teams also carried out rescue operation in low-lying areas in Khatodara.

Sachin Police station staff also rescued over 18 people trapped in the low-lying areas

after the rainwater entered their homes in Kharvasa area located on the Dindoli-Bhatiya village road. A police officer told this newspaper that people trapped were rescued and brought to the police station where they were provided food and later shifted to community halls.

The state government posted former municipal commissioner Shalini Agrawal as Special Officer to oversee rescue and relief operations.

### CM to visit today

Chief Minister Bhupendra Patel reviewed the rain situation across the state at a cabinet meeting in Gandhinagar and instructed ministers to visit rain-affected districts to oversee relief and rescue operations. Patel himself will visit Surat and Valsad on Thursday, said minister Jitu Vaghani.

Union Home Minister Amit Shah spoke with the chief ministers of Maharashtra, Gujarat, and Jammu and Kashmir to take stock of the situation arising from heavy rains there and assured them of all possible assistance from the Centre, officials said. (WITH PTI INPUTS)

## Govt removes 20-m length norm for fishing boats to avail diesel VAT relief

THE GUJARAT government on Wednesday decided to do away with the 20-metre length restriction for mechanised fishing boats in availing benefits under the Diesel VAT Relief Scheme in the "larger interest of the fishing community".

The decision was taken in a state Cabinet meeting chaired by Chief Minister Bhupendra Patel.

"...under the earlier provisions, only mechanised fishing boats measuring less than 20 metres in length were eligible for the scheme. The State Cabinet has now removed this restriction in the larger interest of

the fishing community. As a result, all mechanised fishing boats in Gujarat, including deep-sea fishing boats, will now be eligible to avail the benefits of the scheme," state government spokesperson and minister Jitu Vaghani said, according to an official statement.

"...with this decision, more than 18,000 registered mechanised fishing boats across Gujarat will become eligible for diesel VAT relief," Vaghani added. The release also stated, "...all eligible mechanised fishing boats will be issued a diesel card under the scheme. Cardholders will receive diesel VAT relief of up to Rs 15 per litre. However, if the applicable VAT is less than Rs 15 per litre, the

subsidy will be limited to the actual VAT amount."

Quoting Vaghani, the release said, "...extending this benefit to fishermen operating small, medium and large mechanised boats alike will significantly reduce their daily fuel expenses, strengthen their financial condition and enhance their income."

To avail benefit of the scheme, it is mandatory to register the boat on Real Craft Portal — an online facility of the Central government for the registration and licensing of fishermen's boats.

Vaghani urged the fishermen who have not registered their boats on Real Craft Portal to do so at the earliest.

## Navy UAV crashes near Porbandar city during training sortie; no casualties

Porbandar: An unmanned aerial vehicle (UAV) of the Indian Navy crashed into an open field during a training sortie near Porbandar city on Wednesday afternoon shortly after taking off from an air enclave and no casualties were reported, officials said. The UAV crashed in an open field at Dharampur village, around 6km from the coastal city in the Saurashtra region, Porbandar District Collector S D Dhanani said.

The cause of the crash was yet to be ascertained, he added.

"A UAV of the Indian Navy crash-landed near Dharampur village. No one was killed or injured in the incident. Navy per-

sonnel reached the spot and started further investigation," Dhanani told mediapersons.

The officials said the UAV had taken off from the Naval Air Enclave in Porbandar before it went down in the

nearby field.

"Indian Navy confirms the crash of Uncrewed Aerial Vehicle Drishti-10, off Porbandar airfield during a training sortie this afternoon," the Navy said on their official X handle. PTI
