IndiGo Ventures invests in AI company Sarvam

IndiGo Ventures, the corporate venture capital arm of IndiGo, on Friday said it has invested in artificial intelligence (AI) company Sarvam as part of its Series-B funding round. The investment amount was not disclosed. IndiGo and Sarvam are already working together on AI applications for customer service, employee productivity and airline operations. The companies will continue to develop and test these applications, with successful use cases potentially expanded across IndiGo's network.

Amaravati to get India's first dedicated AI varsity campus

In a major step towards positioning Amaravati as a national hub for advanced technology, research and innovation, the Andhra Pradesh government has approved the establishment of India's first dedicated Quantum and artificial intelligence University campus by the NIELIT Deemed-to-be University, under the Ministry of Electronics and Information Technology. The campus will come up on 8.5 acres in Amaravati with a proposed investment of ₹730.70 crore over five years, fully proposed to be funded through Government of India Grant-in-aid from MeitY. The decision was taken at the CRDA Authority meeting chaired by Chief Minister N Chandrababu Naidu at on Thursday.



New technologies to enhance ease of doing work: V-P
Vice-President C.P. Radhakrishnan on Friday said new technologies will enhance ease of doing work and help create more jobs. While launching end-to-end sovereign AI stack for Indian enterprises and public institutions, Gnani Artha, the V-P said concerns over job loss wire raised when computers wire introduced in the country, instead the IT industry has turned out to be the biggest job creator not only within the country but overseas as well. He said even many highly qualified people are raising concerns about a reduction in jobs due to AI.

Anthropic in talks with startup MatX to speed up chip design

Anthropic discussed buying artificial intelligence chip startup MatX for roughly \$7 billion, seeking to accelerate efforts to develop custom hardware for its fast-growing AI business, two people briefed on the matter told Reuters. The merger talks, which a third person said have evolved into a discussion about a partnership, underscore the AI lab ambition to secure the resources and talent needed to build its own chips.

The goal is to help Anthropic accelerate its in-house chip development. Reuters is reporting on the discussions for the first time but could not learn why the talks are no longer active. MatX, founded by former Google tensor processing unit engineers, is now seeking to raise new capital at a valuation of about \$4 billion, one of the people said, requesting anonymity to discuss private matters.

AI usage by logistics firms boosts delivery timelines of startups

Artificial intelligence (AI) is becoming core to logistics firms' work, helping direct-to-consumer (D2C) and ecommerce companies to reduce failed deliveries by up to 20 per cent and save money, executives said. During January-March, intimate wellness startup MyMuse was grappling with a surge in failed deliveries. Nearly 30 per cent of its orders were flagged as non-delivery reports (NDRs), forcing customer support executives to spend 48 to 72 hours on resolution. The company then deployed Parth, an AI-powered voice agent developed by logistics platform ClickPost. The two companies did an internal study that allowed the wellness startup to automate its NDR management through AI. Consequently, MyMuse is now resolving 80 per cent of NDR cases within a day. "Failed deliveries are a huge challenge for D2C brands. Companies spend heavily to acquire customers, but if 30 per cent of orders face delivery failures and a large share eventually become return-to-origin (TRO), profitability takes a direct hit," said Naman Vijay, cofounder and chief executive officer of ClickPost. The example marks a trend in which D2C and ecommerce firms are turning to AI to fix a major drain on profits: Failed deliveries and TRO shipments. TRO occurs when an order cannot be delivered — due to bad addresses, failed attempts, or customer refusal — and is shipped back to the seller. ClickPost estimates that brands using Parth have seen TRO rates decline by 15-20 per cent. Shiprocket, an ecommerce logistics services firm, has integrated AI across its platform rather than offering it as a standalone product. "AI is not something we have deployed on top of our operations. It is how the platform



An analysis by Unicommerce, based on summer sales this year, found that brands were able to limit RTO rates to 17 per cent, compared with nearly 25 per cent during the corresponding period last year, following AI deployment was built and continues to evolve," said Prabhat Singh, senior vice-president of product management at Shiprocket. The company's AI capabilities span checkout, courier allocation and last-mile delivery. Shiprocket Checkout verifies customers' last successful delivery address before an order is placed, while its AI-powered Courier Recommendation Engine recommends the most suitable logistics partner for a shipment. Around 40 per cent of sellers on the platform use the recommendation engine for their orders. The platform also notifies customers before delivery and allows them to reschedule deliveries if they are unavailable, addressing one of the leading causes of failed delivery attempts. According to Shiprocket, an ecommerce enablement software-as-a-service platform, AI-driven interventions have helped reduce RTOs by nearly 20 per cent across its platform. An analysis by Unicommerce, based on summer sales this year, found that brands were able to limit RTO rates to 17 per cent, compared with nearly 25 per cent during the corresponding period last year. The improvement came on the back of deploying AI for delivery optimisation and customer communication to reduce fulfilment-related losses. Kapil Makhija, managing director and chief executive officer of Unicommerce, said: "AI continues to be a strategic focus area for Unicommerce. We are consistently investing in strengthening our technology capabilities and embedding AI across our product suite to help brands improve operational efficiency, enhance customer experience and drive sustainable business growth." Wellness brand DrVeda increased successful deliveries from 79 per cent to 85 per cent, while women's wellness brand Krivy improved its rate from 89 per cent to 93 per cent. Skin-care brand Be Clinical raised its delivery success rate from 65 per cent to 71 per cent. Zippee, a quick-commerce logistics firm, has rolled out multiple AI agents across its last-mile delivery operations. These include an Address Intelligence Agent that enriches low-confidence delivery addresses, a Rider Performance Coach, a Control Tower Agent for monitoring service levels, and AI-powered customer support and compliance tools. According to Mohit Singh, head of product at Zippee, these AI deployments have reduced manual operational monitoring by 15-30 per cent, improved first-attempt success rates by 5-8 per cent, reduced RTOs by 10-15 per cent, and increased rider productivity by 10-12 per cent.

Sandhya Devanathan exits Meta after a decade; to join OpenAI



Sandhya Devanathan will join OpenAI as V-P for Southeast Asia and Australia

Sandhya Devanathan, Meta's vice-president and head for India and Southeast Asia, is leaving the social media giant after more than a decade and is all set to join OpenAI as vice-president for Southeast Asia and Australia. In this newly created role, Devanathan will be OpenAI's most senior leader in South East Asia and Australia, with responsibility for its performance across consumer growth, enterprise adoption and partnerships, regulatory engagement and operations. The Meta veteran penned an emotional post on LinkedIn, announcing her departure from Meta and said she is looking forward to her "next exciting chapter". She, however, did not divulge her next move. OpenAI, though, confirmed that Devanathan will join as vice-president for Southeast Asia and Australia.

Qcom, ecom players see rise in customised rakhi demand

Customers increasingly turned to quick-commerce (qcom) and ecommerce (ecom) channels for Raksha Bandhan shopping this year. On Flipkart Minutes, festival shopping grew threefold year-on-year (Y-o-Y), with GenZ accounting for more than 40 per cent of shoppers. Rakhis and fashion *maang tikkas* emerged as the fastest-growing categories, recording 20 times and four times growth, respectively. Precious earrings, gold and silver coins and bars, and pooja *thalis* sets also saw strong demand. The qcom platform sold over 2,000 rakhis per minute, while mobile handsets, true wireless earbuds, gold coins and bars, and smartwatches emerged among the top gifting categories. Ethnic wear also emerged as a popular last-minute purchase, with orders for men's kurtas rising 87 per cent Y-o-Y. Amazon Now, the qcom vertical of ecom giant Amazon, said chocolate gifts were the fastest-growing category, up 2.5 times compared to business as

usual, while Kaju Katli saw two times growth. "Our rakhi store brought together more than 500 unique rakhis, festival essentials and gifting options in one place, with the fastest rakhi order delivered in under five minutes. This year, we saw a clear shift towards premiumisation and personalisation in gifting — customers moved beyond regular options to more indulgent ones," said Nishant Sardana, director, Amazon Now. Qcom-only platform Zepto also saw demand spread across metros as well as regional markets. On the platform, consumers purchased traditional *Roli-Chawal* and *Rudraksha*

rakhis alongside evil-eye, silver- and gold-plated and multi-pack variants. Chocolates, beauty products and nut boxes were among the popular gifting choices. Delhi alone accounted for one in every 10 rakhis sold on Zepto. At Swiggy Instamart, rakhi orders grew nearly 300 per cent Y-o-Y. Chocolates and *mithai* orders were up by 30 per cent, compared to the week before rakhi. Gift hampers are up 85 per cent week-on-week, smartwatches nearly doubled at 99 per cent, and premium designer rakhis grew 130 per cent. Searches for jewellery brands such as Kalyan Jewellers, Palmonas and GIVA also increased. The platform had said that the overall rakhi-gifting segment could grow around threefold this year. On the ecom side, Meesho saw orders grow 36 per cent Y-o-Y and gross merchandise value rise 38 per cent during the festival. For Meesho, nearly 73 per cent of rakhi orders came from non-metro markets, while rakhis with personalised names emerged as a notable trend, pointing to rising demand for customised gifting.
