A copy of the communication received from Dayal Institute of Medical Sciences Limited is enclosed for the information of the Exchange.

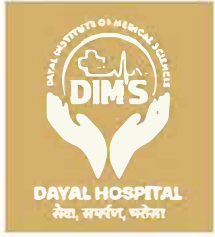

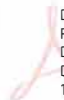
