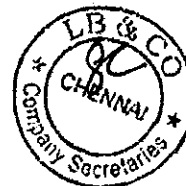

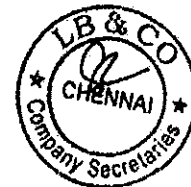
Respected Sir,

We, M/s LB & Co, Company Secretaries were appointed as Scrutinizer by the M/s Chennai Petroleum Corporation Limited ("the Company") for the purpose of Scrutinizing the voting process i.e. remote e-voting and instapoll at Annual General Meeting (AGM) under the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended from time to time) and General Circular Nos. 14/2020, 17/2020, 20/2020 & 22/2020 issued by the Ministry of Corporate Affairs on April 08, 2020, April 13, 2020, May 05, 2020 and June 15, 2020 respectively and SEBI Circular dated May 12, 2020 (MCA & SEBI Circulars) on the resolution(s) mentioned in Notice dated August 17, 2020 ('Notice') for 54th AGM of the Company held on September, 11, 2020 at 03:00 P.M through Video Conferencing (VC)/ other Audio Visual Means (OAVM). We submit our report as under:

1. The management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and rules relating to e-voting facility for AGM and on the resolutions contained in the Notice of 54th Annual General Meeting (AGM) of the members of the Company. Our responsibility as scrutinizers is restricted to make a consolidated scrutinizer's report of the votes cast 'For' or 'Against' and/or abstain/invalid towards the resolutions as stated in the AGM Notice.
2. The Annual Report for the year 2019-20 containing Notice dated August 17, 2020 along with statement setting out material facts under Section 102 of the Act was dispatched to the Shareholders through e-mail to shareholders whose email IDs are registered with the Company/Depository Participant(s) on Tuesday, August 18, 2020.



3. As per the provisions of Rule 20 of the Companies (Management and Administration) Rules, 2014, the Company has published advertisement about having sent the notice of Annual General Meeting and providing e-voting facility in 'The Hindu' (English daily newspaper) and in 'Makkal Kural' (Tamil daily newspaper) on Wednesday, August 19, 2020.
4. In terms of the aforesaid Notice, voting through electronic means was kept open for 4 (Four) days from Monday, September 07, 2020 (09:00 A.M) to Thursday, September, 10, 2020 (05:00 P.M).
5. The voting rights of members were considered in proportion to their shares in the paid up equity share capital of the Company as on the cut-off date i.e. Friday, September, 4, 2020.
6. After completion of instapoll at the AGM, the data of instapoll at AGM was diligently scrutinized. Thereafter, data of instapoll at AGM were reconciled with the records maintained by the Registrar and Share Transfer Agent of the Company. Detailed registers were maintained containing the summary of results of remote e-voting and instapoll at AGM.
7. Thereafter, the votes cast through remote e-voting were unblocked after completion of instapoll at the AGM in the presence of two witnesses Mr S Neeraj and Ms V Sukanya, who are not in employment with the Company.
8. The shareholders exercised their voting either by remote e-voting or instapoll at AGM. There was no shareholder who opted for both the facilities. Further, shareholders who have voted for lesser number of shares as compared to their entitlement, the number of shares for which they actually voted was considered.

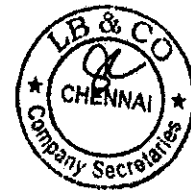

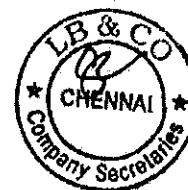

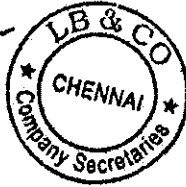
