Sub: FIXATION OF RECORD DATE FOR THE PURPOSE OF FINAL DIVIDEND FOR THE YEAR 2024-25

This is further to our communication dated 25th April 2025, wherein it was informed that the Board of Directors of Chennai Petroleum Corporation Limited at their Board Meeting had recommended a final equity dividend of **Rs. 5/- per share (i.e. @ 50% on the paid up equity share capital) for the financial year 2024-25**, subject to the approval of the members of the Company in the forthcoming Annual General Meeting (AGM) of the Company.

Pursuant to Regulation 42 of SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015, it is hereby informed that the Company has fixed **Friday, the 01st August, 2025** as the **“Record date”** for the purpose of ascertaining the eligibility of members for payment of final equity dividend of Rs. 5/- (Rupees Five Only) per equity share on the face value of Rs. 10/- each for the year 2024-25.

The final dividend, if approved by the members in the forthcoming AGM, will be paid to the eligible members within the stipulated period of 30 days from the date of AGM. Members may note that the Income Tax Act, 1961, as amended by the Finance Act, 2020, mandates that dividends paid or distributed by a company is taxable in the hands of members. The Company shall therefore be required to deduct tax at source (“TDS”) at the time of making the payment of dividend. In order to enable the Company to determine the applicable TDS rate, members are requested to submit the relevant documents on or before **Wednesday, the 13th August, 2025**.
