1. Financial results submitted is not as per format prescribed by SEBI CA certified utilization to be given:

We respectfully submit that the financial results were prepared in the prescribed SEBI format; however, the Chartered Accountant (CA) certified statement of utilization of funds was inadvertently missed at the time of submission. We regret the oversight and are enclosing the said CA-certified utilization statement herewith.

2. Machine Readable Form / Legible copy of Financial Results not submitted PDF readable:

The earlier uploaded copy of the financial results along with the other documents were not in a machine-readable or legible format. This was due to unawareness about the revised submission requirements under the latest SEBI circulars. We apologize for the non-compliance and are now enclosing a proper machine-readable PDF version of the financial results.

3. Limited Review Report / Independent Auditor's Report not in prescribed format (Consolidated Financials showing Standalone caption):

While the heading of the report correctly stated that it pertains to the consolidated financials, the body of the report erroneously included references to "Standalone". This was an inadvertent clerical error, and we are enclosing the revised and corrected Independent Auditor's Report for your kind perusal.

We request you to kindly take the revised documents on record and consider the above lapses as unintentional. We assure you of our commitment to maintaining the highest standards of regulatory compliance going forward.

Opinion:

We have audited the standalone financial results of "Chetana Education Limited" (the Company"), for the year ended 31st March, 2025 ("the Statement"), being submitted by the company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulation 2015 ('the Regulation') as amended (the "Listing Regulations").

This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding of the assets of the Company and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial results that give a true and fair view and are free from material misstatement, whether due to fraud or error.

Company for the year ended 31st March 2025, on which we have issued an unmodified

audit opinion.

The Statement includes the results for the half year ended 31st March 2025 being the

balancing figure between the audited figures in respect of the full financial year and the

published unaudited year to date figures, up to the first half of the year of the current

financial year which were subject to limited review by us. Our report on the Statement is

not modified in respect of this matter

- The standalone financial result for the half year and year ended 31st March 2025 have been prepared in accordance with the requirement of Accounting Standards (AS) prescribed under Section 133 of the Companies Act 2013 read with relevant rules thereunder and in terms of Regulation 33 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended. As per MCA Notification dated 16th February 2015 companies whose shares are listed on SME exchange as referred to in chapter XB of SEBI (issue of capital and disclosure requirements) Regulations 2009, are exempted from the cumpulsory requirement of adoption of IND-AS.
- The financial results for the corresponding previous year ended 31st March 2024 represent the operations of the Company for the period from 21st January 2024 to 31st March 2024 only, subsequent to its conversion from a Limited Liability Partnership (LLP), formerly known as Chetana Education LLP.

Had the conversion from LLP to Company occurred at the beginning of the financial year, the consolidated financial results of the LLP and the Company for the full year would have been as follows:
