## **Career Launcher Founder Satya Narayanan welcomes PM Modi's Independence Day Announcement of Free Online Coaching and AI Skilling for 1 Crore Youth**

**New Delhi, August 15, 2026** — CL Educate Limited (BSE|NSE-listed), the diversified education services group behind Career Launcher, DEXIT Global, and mySATHI Foundation, today welcomed Prime Minister Narendra Modi's announcement — made during his 80th Independence Day address from the Red Fort — of free online coaching for competitive examinations and a nationwide programme to train one crore youth in Artificial Intelligence over the coming year.

In his address, the Prime Minister noted that the burden of coaching costs on middle-class and poor families had become unsustainable, and that India's Digital Public Infrastructure (DPI), together with its base of talented teachers and educators, gave the country the foundation to solve this at national scale.

*"This is precisely the vision Career Launcher was built to serve — that access to quality preparation and quality skilling should never be a function of a family's postal code or income,"* said Satya Narayanam R, Founder and Group Chairman, CL Educate Limited.

The Prime Minister's announcement validates a direction we have invested in for years, and we stand ready to contribute our platforms, our people, and our on-ground experience to make this a success."*, he said.

The pilot goes beyond technology deployment: it is actively building a network of local teachers and educators onto the DPI layer itself, ensuring that the platform's value is delivered through trusted, hyper-local relationships rather than a one-size-fits-all digital rollout — a model designed explicitly for the kind of scalable, last-mile success the Prime Minister's vision demands.

## Looking Ahead

CL Educate said it looks forward to working with the Ministry of Education, NTA, and state governments to extend the learnings from the Ghaziabad DPI pilot and DEXIT's assessment infrastructure to the national programme, and reaffirmed its commitment to India's Viksit Bharat 2047 vision of a digitally empowered, AI-ready youth population.
