Death toll from quakerises to 132 in Colombia

Bogota, 11 August

At least 132 people have been killed and 570 injured after a powerful magnitude 7.4 earthquake struck western Colombia, prompting President Abeloardo de la Espriella to declare a national state of emergency as rescue teams searched collapsed buildings for survivors.

The earthquake, described by Colombia's Geological Service as the strongest recorded in the country this century, struck near San José del Palmar in an underdeveloped area of western Colombia, about 150 miles (240 kilometres) west of Bogotá.

Rescueteams were working to search for survivors beneath the rubble as authorities warned that the death toll could rise.

Among the damaged structures were the pediatric and neonatal sections of a hospital in Cali, while 86 buildings were reported to have collapsed across the country.

Pereira, in Colombia's coffee-growing region, reported the highest number of fatalities, with at least 60 deaths, according to the Colombian Association of Capital Cities.

Authorities also said 188 people were missing in Cali. Five capital cities were placed under red alert, while seven airports suspended operations.

Trump switched planes in Turkey using catering truck over Iran threat

US President Donald Trump was secretly moved from Air Force One to a smaller military aircraft using an airport catering truck during his departure from Turkey last month, in an elaborate security operation prompted by an Iranian assassination threat, *The Washington Post* reported.

According to the report, Trump publicly boarded the older Air Force One in Ankara on 8 July after attending the NATO summit. However, minutes later, he and several aides were covertly transferred to a US Air Force C-32A aircraft parked elsewhere on the tarmac.

The unusual operation reportedly involved an airport catering truck being raised to the aircraft door on the side of Air Force One away



from the cameras, allowing Trump to leave without being detected.

The older Air Force One then departed for the UK with members of the White House staff and journalists, effectively serving as a decoy while Trump travelled separately aboard the C-32A.

The *Post* reported that the manoeuvre concealed Trump's actual location from the American public and some senior US officials for several hours. The C-32A was not visible in publicly available flight-tracking data, while the aircraft carrying the press

corps landed in Britain under the Air Force One call sign.

US Defence Secretary Pete Hegseth reportedly boarded the C-32A separately using its external stairs, in what sources described as part of an effort to make the aircraft's use appear routine. The C-32A is commonly used to transport senior US officials and other VIPs.

The operation was reportedly triggered by concerns over a potential Iranian threat to Trump. The *Post* said it remained unclear what specific intelligence prompted the extraordinary security measures.

Trump seeks compensation from Iran amid Strait of Hormuz standoff

US President Donald Trump added a fresh demand for Iran to compensate the United States for the harm committed by Tehran over the past 50 years, further escalating the

standoff over the reopening of the Strait of Hormuz.

Trump's comments came after Iranian officials said the United States should compensate Iran for damage caused during the five-month conflict and linked any reopening of the vital waterway

to a series of demands, including an end to US military action and sanctions. "I am likewise demanding compensation from Iran," Trump said in a post on social media, citing deaths and injuries he attributed to Iranian actions over decades. "I have instructed my

representatives to put this firmly into any, and all, future negotiations," he added.

Speaking to reporters at the White House, Trump said Iran should pay damages for what he described as harm caused over the past 50 years.

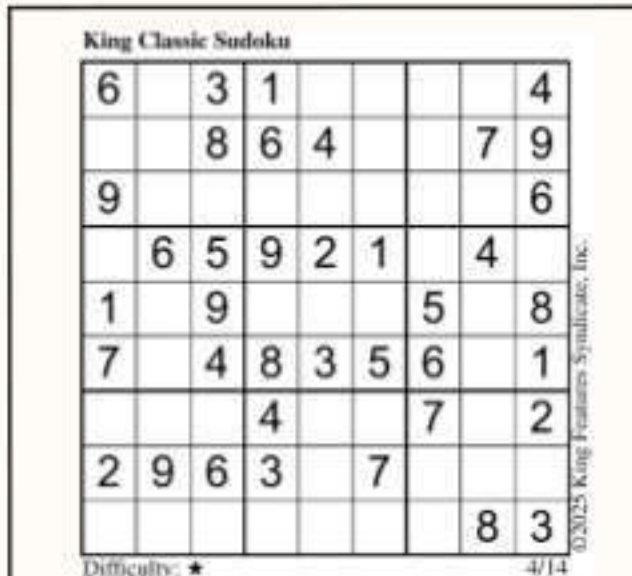

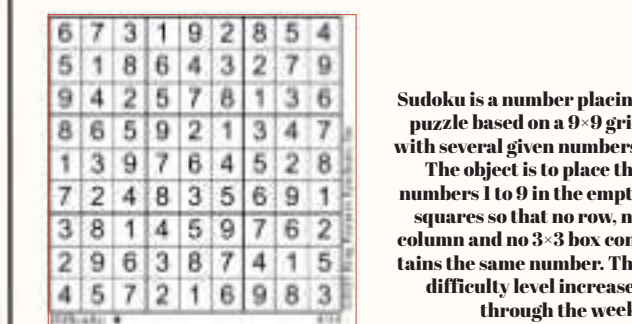
