**Subject: Disclosure under Regulation 30 and Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015**

Dear Stakeholders,

In continuation to our earlier intimation dated 09<sup>th</sup> April, 2025, please be advised that, for a period of 90 days, Indian exporters will incur an additional tariff of 10% instead of the previous rate of 26% with immediate effect. This reduction provides measurable relief for the current quarter.

In a related update, USA President Donald Trump has announced a temporary suspension of reciprocal tariff impositions for 90 days for the majority of trading nations, with the sole exception of China. This decision follows consultations with representatives from over 75 countries who have engaged in negotiations without initiating any retaliatory actions. Consequently, a reduced reciprocal tariff of 10% will apply during this period, while a baseline tariff of 10% remains in effect for all.

While we remain optimistic that our government will secure a favourable, long-term deal for the sector, we also acknowledge the ongoing uncertainties in the global trade environment. Therefore, we are maintaining a cautiously proactive approach as we continue to monitor developments closely.

The aforesaid disclosure is being done under abundant caution and compliance.
