Pursuant to Regulation 30 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("SEBI LODR Regulations") and in continuation to our letter/intimation dated January 03, 2025 we hereby inform that a Settlement Agreement has been executed in the matter concerning the Revenue Share Development Agreement between The Ruby Mills Limited ("the Owner") and Mindset Estates Private Limited ("the Developer").

The key particulars of the Settlement Agreement are as follows:

- The Settlement Agreement was executed on December 11, 2025 by Hon'ble Justice **Mr. Sharukh J. Kathawala** (Retd.), appointed as the Mediator under the applicable framework.
- The Settlement Agreement records the mutual understanding arrived at between the parties with respect to the matters in determining the amount due for Cessation of the "**Development Agreement**" (D.A.).
- All rights, obligations, asset allocations, and responsibilities between the parties have been finally determined as per the terms of the Agreement.
- The parties have agreed that the Settlement Agreement shall constitute a full and final settlement, and no further claims shall subsist outside the scope of the Agreement.
- The Agreement is binding on all parties.
