iv. **Details of the violation(s)/contravention(s) committed or alleged to be committed:** It has been alleged that ineligible ITC has been availed and tax not paid on Other Income.

v. **Impact on financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible:** On the basis of our internal assessment, the company believes no excess Input Tax Credit is availed and utilized by the company. There is no material impact on financial, operations or other activities of the company due to the above. Appropriate action, including filing of appeal in this matter are being taken by the Company.
