1. In Point No. 1 of the Board's Report appearing on page no.26 under the heading "FINANCIAL RESULTS (Standalone and Consolidated)" of Board's Report in the Annual Report of the Company,

- a) In the Standalone sub-column of the Current year column, "Expenditure" should be read as "66364.30" instead of "66364.29". Further Profit from Associates be corrected to 203.85 instead of 203.35 and Profit after associate and exceptional items and tax and Profit before tax be corrected to 6506.81 instead of Rs. 6506.31.

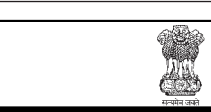

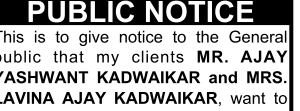
