Sub: - Intimation regarding lapse of warrants and forfeiture of upfront payment

Dear Sir/ Madam,

Pursuant to the provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, and in continuation to our earlier intimations regarding the allotment of warrants, we hereby inform you that the Company had allotted 99,99,000 warrants on 12th September, 2024 on a preferential basis, entitling the warrant holders to apply for and be allotted equivalent number of equity shares of the Company within a period of 18 months from the date of allotment i.e. 12th September, 2024.

The Company had issued three reminders to the warrant holders, requesting them to exercise the option for conversion of the warrants into equity shares within the stipulated time period i.e. 11th March, 2026, but the allottees as enlisted in the attached **Annexure -1** have not exercised the option of conversion within the stipulated period, Hence, the said warrants have lapsed with effect from 12th March 2026.

Accordingly, in terms of SEBI (Issue of Capital and Disclosure Requirement) Regulations, 2018, the upfront amount of Rs.5,11,79,882 i.e. 25% of the issue price received at the time of allotment of warrants stands forfeited by the Company.
