SUMMARY OF THE PROCEEDINGS OF THE 32ND ANNUAL GENERAL MEETING OF CORAL INDIA FINANCE AND HOUSING LIMITED

The 32nd Annual General Meeting (AGM) of the Company was held today i.e. on Friday, September 11, 2026 through Video Conference (VC) /Other Audio Visual Means (OAVM) in accordance with the applicable provisions of the Companies Act, 2013 read with the Rules issued thereunder, the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and all the relevant circulars issued by Ministry of Corporate Affairs and Securities and Exchange Board of India. The AGM commenced at 11:00 a.m. (IST) and concluded at 11:24 a.m. (IST).

Mr. Navin Doshi, Chairman and Managing Director of the Company chaired the proceedings of the AGM and welcomed all the Directors, shareholders and participants of the Company to the AGM.

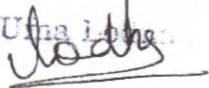
