- 2) The above results are reviewed by statutory auditor and Audit Committee of the company and approved by the Board of Director at their meeting held on 10th August, 2024.
- 3) The figures of the quarter ended on 31st March, 2024 represent the balancing figures between audited figures in respect of full financial year and the unaudited published figures upto 9 months of the relevant financial year.
- 4) Previous period figures have been regrouped/reclassified/rearranged wherever necessary to make them comparable to figures of the current periods.
- 5) The company does not have more than one reportable segment in terms of AS-17 issued by ICAI hence Segment wise reporting is not applicable.
- 6) The Company has sold the Fixed Assets during the quarter into consideration with a loss of Rs. 39.50 Lacs, which affected the profitability of the Company, and this figure is included under as exceptional items.
- 7) The Company has changed its Accounting Policy towards depreciation. The difference in the depreciation charged in the financials of the preceding years of Rs. 1267.54 Lacs has been included in the exceptional items as profit and deferred tax provisions have also been made.
