Dear Sir/Madam,

We wish to inform you the following brief update for CSL Finance Limited for the quarter & year ended March 31, 2023; the detailed presentation shall follow with the financial results:

- Assets under management (AUM) stood at approximately INR 738 cr. as at March'23, as compared to INR 519 cr. as of March'22
- Cumulatively the company raised **INR 270 cr.** during the financial year 2022-23
- **New** lenders on boarded during the quarter – Utkarsh small finance bank, Fincare small finance bank, STCI finance, Muthoot Capital from whom we raised INR 75 cr. along with the existing Banks and FIs.
- New loans booked during the quarter were INR 75 cr. in SME and INR 82 cr. in Wholesale
- Liquidity surplus stood at approximately INR 50 cr. as at Q4 FY'23. The Company's liquidity position remains strong
- The Company continues to remain well capitalized with capital adequacy ratio (CAR) of approximately 55% in Q4 FY'23
