Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI master circular dated 11th November, 2024, we are disclosing that Nomination and Remuneration Committee of UTI Asset Management Company Limited has approved; on 21st May, 2025 at 1940 hrs IST; the allotment of 8,475 equity shares of face value of ₹10 each pursuant to the exercise of options by eligible employees under ‘UTI AMC Employee Stock Option Scheme – 2007’.

Post the aforesaid allotment, the issued and paid-up share capital of the Company shall be increased from ₹ 1,28,00,86,420 (12,80,08,642 equity shares of face value of ₹10 each) to ₹ 1,28,01,71,170 (12,80,17,117 equity shares of face value of ₹10 each).

The new equity shares shall rank *pari-passu* in all respects with the existing equity shares.
