Subject: Disclosure under Regulation 29(1) read with Regulation 29(4) of the Securities and Exchange Board of India (Substantial Acquisition of Shares and Takeovers) Regulations 2011 ("Takeover Regulations").

Enclosed is a disclosure made by Catalyst Trusteeship Limited ("**Onshore Security Agent**") under Regulation 29(1) read with Regulation 29(4) of the Securities and Exchange Board of India (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 (the "**Takeover Code**").

A facility agreement dated 23 February 2026 ("**Facility Agreement**") had been entered into between, *inter alia*, Centella Mauritius Holdings Limited ("**Borrower**") and certain lenders ("**Facility**").

The Borrower had previously marked a pledge in the depository system in favour of the Onshore Security Agent over 4,651,992 equity shares ("**Initial Shares**") constituting approximately 0.5% of the issued and paid-up share capital of Aster DM Healthcare Limited held by it on March 5, 2026.

Pursuant to a merger between Aster DM Healthcare Limited and Quality Care India Limited (collectively, the "**Merging Entities**"), a pledge has been marked in the depository system over an additional 79,773,555 equity shares issued and allotted to the Borrower ("**Additional Shares**", together with the Initial Shares referred to as the "**Shares**"), constituting approximately 9.2% of the issued and paid up share capital of the resulting entity, Aster DM Quality Care Limited ("**Target Company**"), on account of an automatic corporate action arising from the merger between the Merging Entities. As a result, while the Borrower has not undertaken any formal steps or actions for the purpose of creating such pledge over the Additional Shares, a pledge has been marked in the depository system over an aggregate number of 84,425,547 Shares, constituting approximately 9.7% of the issued and paid-up share capital of the Target Company held by the Borrower.
