**Sub.: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015**

**Reg.: Set aside of the GST Demand Orders dated April 26, 2024 passed against the Company**

Dear Sir/Madam,

This is in furtherance to our Letter dated May 01, 2024 whereby, in compliance of Regulation 30 read with sub-para 20 of Para A of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”), we informed you about the receipt of the Orders dated April 26, 2024 (“GST Orders”) passed by the Goods and Services Department (“GST Authority”) under section 73 of the SGST/CGST Act, 2017 demanding a sum of Rs. Rs. 74,21,917 towards ITC, interest and penalty, and a sum of Rs. 14,03,038 towards interest for the late payment of tax, with respect to the financial year 2018-19.

Against the GST Orders, on July 02, 2024, we filed a Writ Petition (bearing No. W.P.(C) 9401/2024) before the Hon’ble High Court of Delhi, New Delhi. The matter was listed for hearing on July 23, 2024 where the Hon’ble High Court of Delhi set aside the GST Orders and remanded the matter to the Adjudicating Authority for considering afresh.

Details as required under Regulation 30 of the Listing Regulations read with SEBI circular SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023, are enclosed as **Annexure-A**.
