a) Share Certificates relating to the Share Transfer Deeds received during the period 1st October, 2018 to 31st March, 2019 as entered in the Memorandum of Transfers have been issued with delays beyond the stipulated period of fifteen days of the date of lodgement for transfer, sub-division, consolidation, renewal, exchange or endorsement of calls / allotment monies from respective date of lodgement of each deed including those rejected on technical grounds. *During this period the company received 27 applications for transfers covering 332 equity shares. The company has obtained explanation from the RTA that the delays are due to spurt in volumes of demat requests and related transfers / transmissions due to change in the SEBI regulations (mainly change in the LODR banning physical transfers w.e.f. 5th Dec 2018 which was subsequently extended till 31st March 2019)*
