Ref: Intimation filed vide reference no. 74/2024-25 dated July 7, 2024.

This is in connection with our previous intimation dated July 7, 2024 wherein we had intimated the exchanges regarding the receipt of demand under rule 33(11) of the Maharashtra Municipal Corporations (Local Body Tax) Rules raising demand of Rs. 5,71,92,212/ (Tax – Rs. 1,42,96,803, Penalty – Rs. 2,85,98,606/- and Interest – Rs. 1,42,96,803/-) and Rs. 3,81,99,364/ (Tax – Rs. 95,48,591, Penalty – Rs. 1,91,02,182/- and Interest – Rs. 95,48,591/) pursuant to the assessment order passed by the Office of The Deputy Commissioner of Vasai-Virar City Municipal Corporation dated July 5, 2024 for the financial year 2014-15* and 2015-16* respectively.

We had also intimated that the Company will be filing an appeal against the said order before The Commissioner of Vasai-Virar City Municipal Corporation. In connection with the same, we have now received the order from the Commissioner of Vasai-Virar City Municipal Corporation confirming the order passed by the Deputy Commissioner of Vasai Virar Municipal Corporation. Based on the merits of the matter, prevailing law and the advice of the consultant, the Company is planning to appeal against this order in line with the provision of Section 406 of Maharashtra Municipal Corporation Act, 1949 and reasonably expects favourable order from the appellant authorities.
