100 days Campaign - “Saksham Niveshak”: July 28, 2025 to November 06, 2025 update your KYC details and claim your unpaid/ unclaimed dividends

The Ministry of Corporate Affairs (“MCA”) through circular dated July 16, 2025 requested the Companies to launch a **100 days Campaign - “Saksham Niveshak” starting from July 28, 2025 to November 06, 2025**, to reach out to shareholders whose dividend remained unpaid/ unclaimed.
