With reference to the captioned subject, we would like to inform you that the Company has received an order from the office of the Assistance Commissioner of Central Tax, Vijaywada, CGST divisional office, Andhra Pradesh for the period April 2019 to March 2020 imposing demand of INR 4,50,41,295/- (Tax INR 1,39,98,461/-, interest INR 1,70,44,373/- and penalty of INR 1,39,98,461/-).

Based on the merits of the matter, prevailing law and advice of the consultant, the Company is planning to appeal against this order before the Commissioner (Appeals) and reasonably expects favourable orders from the appellent authorities.
