With reference to the captioned subject, we would like to inform you that the Company has received a notice of demand under section 156 of the Income Tax Act 1961 (the 'Act') from the office of the Assessment Unit, Income Tax Department, Mumbai, for the AY 2024-25, imposing total demand of ₹ 42,60,90,820/- (Tax ₹ 34,53,31,204 and Interest - ₹ 8,07,59,616).

Based on the Company's assessment, prevailing law, and basis the advice of the consultant, the Company reasonably expects a favourable outcome at the Appellate level. The Company will file an appeal before the National Faceless Appeal Centre ('NFAC') within the timeline as prescribed under section 249 of the Act.
